If an incumbent has not filed by August 8, 2014, any qualified person, other than the incumbent, may file by no later than 5:00 p.m. on August 13, 2014.

If by 5:00 p.m. on August 13, 2014, an insufficient number of persons have filed for the Hospital District, Special Districts or Soil Conservation District offices, and a petition for an election has not been filed, appointments will be made pursuant to Elections Code §10515.

If by 5:00 p.m. August 13, 2014, an insufficient number or no nominees have filed for the School District Offices and a petition for an election has not been filed, appointment to each elective office will be made as prescribed by Education Code §5326, §5328, §5328.5.
