## AGREEMENT AND FIRST AMENDMENT TO AGREEMENT RE EMPLOYMENT OF DAVID ANDERSON

This Agreement and First Amendment is entered into this 10th day of December, 2013, by and between David Anderson and the County of Mono (sometimes referred to herein collectively as "the parties") for the purpose of amending that certain Agreement re Employment of David Anderson.

## I. RECITALS

- A. The County currently employs David Anderson in accordance with an employment agreement entered into on or about July 9, 2012 (sometimes referred to herein as "the Agreement").
- B. The parties wish to amend the Agreement to effectuate a change in Mr. Anderson's employment position and compensation.

## II. AGREEMENT

NOW, THEREFORE, the parties agree as follows:

- 1. Effective December 10, 2013, Mr. Anderson's employment position is changed to "Assistant District Attorney" and all references in the Agreement to Mr. Anderson's former job title as "District Attorney III" are hereby amended to instead read "Assistant District Attorney."
- 2. Section 3 of the Agreement is amended to read as follows: "Effective December 10, 2013, Mr. Anderson's base salary shall be \$9,527 per month. Mr. Anderson understands that he is responsible for paying the employee's share of any retirement contributions owed to the Public Employees Retirement System (PERS) with respect to his employment for the County"
- 3. All other provisions of the Agreement not hereby amended shall remain in full force and effect.

#### Dear Commissioner Farrow:

Earlier in July, the Mono County Board of Supervisors invited the California Highway Patrol (CHP) to collaborate on a multi-agency office and visitor center in the historic community of Bridgeport located on the eastern side of the Sierra. The County connected with staff from the CHP Facilities Division and the State Department of General Services (DGS) who have been highly responsive, and we have appreciated their efforts and accessibility. Initial discussions resulted in a site visit to a potential location in Bridgeport for a new CHP facility.

We are also aware that initial site search parameters were released that did not include the Bridgeport community, which causes us concern. As indicated by the attached Resolution from the citizen-based Bridgeport Valley Regional Planning Advisory Committee, the County strongly values the presence of the CHP in Bridgeport. Bridgeport is the center of several government operations in the county, including the CHP and Superior Court, and agency employees and families are important contributors to and supporters of the local community. In addition, Bridgeport is located centrally in Mono County, providing the best year-round access to CHP officers.

The Mono County Board of Supervisors requests the retention of a CHP facility consistent with the County's General Plan in the Bridgeport community. We look forward to working with the CHP to facilitate project development and community engagement, and appreciate your consideration of our request.

**WHEREAS**, the CHP was most effective in Mono County when the officers and employees were required to live in Mono County communities, and as a result connected and established trust with local residents, business owners, and government leaders, and;

**WHEREAS,** CHP officers, employees and their families were important contributors to and supporters of the local community, and the RPAC seeks to retain that value to the extent possible, and:

**WHEREAS**, appropriate sites of adequate size and convenient location are under consideration for the construction of a new CHP facility in Bridgeport.

**NOW, THEREFORE, BE IT RESOLVED** that the Bridgeport Valley Regional Planning Advisory Committee requests that the Mono County Board of Supervisors support the retention of a CHP facility consistent with the County's General Plan in the Bridgeport community, and send a letter requesting this action to the CHP Commissioner and Facilities Commander.

## DISCUSSION

In early 2013, the Board of Supervisors discussed Mono County developing a Legislative Platform to strengthen the County's advocacy at the state and federal level. A draft 2014 Mono County Legislative Platform was developed by staff. This document included legislative items that the Board has already taken a position on from January 2013 to present, as well as additional input provided by departments. In addition, in preparing this draft, staff reviewed the following documents: CSAC 2013 State and Federal Advocacy Priorities, Rural County Representatives of California (RCRC) 2013-14 Policy Principles, the draft Eastern Sierra Council of Governments (ESCOG) Legislative Platform, County of Mendocino 2013 State and Federal Legislative Platform, and Sonoma County 2013 State and Federal Legislative Program.

One of the primary goals of a Legislative Program is to shift the County from being reactive to legislation proposals to being proactive. The Other organizations and Counties which have adopted a Legislative Platform have done so in order to be quicker in response to timely legislative issues.

Legislative Platforms are intended to be living documents which change as the strategic goals of the organization are achieved and as unanticipated items arise during a state or federal legislative session. Items uncovered by the Platform and which the County should address, will be handled in the same manner as they have been in the past, by bringing the issue before the Board for public dialogue and Board direction.

Staff recommends adoption and once adopted a copy of the Platform be forwarded to all of Mono County's State and Federal elected officials. Additionally, as Board members meet with the County's representatives, this platform be utilized to guide Board member led advocacy efforts.

To ensure this platform remain relevant, it is further recommended the Platform be reviewed, updated and adopted annually in December.



## Introduction

Mono County, California, is a rural county situated between the crest of the Sierra Nevada Mountains and the California/Nevada border. It has a land area of 3,030 square miles, or just over 2 million acres, 94% of which is publicly owned. Much of this land is contained in the Inyo and Toiyabe National Forests. As a result, Mono County is home to vast scenic and recreational resources, and has unsurpassed access to wilderness and adventure.

The County is home to, and named after Mono Lake, which is a large high-desert saline lake. Also located in the County is the historic gold rush town of Bodie, which during its heyday in the late 1800's was home to as many as 7,000 people, and is today maintained as a State Historic Park for the public to come and enjoy. The County seat is proudly located in Bridgeport. Scenic Highway 395 weaves its way north-south through the heart of the county, effectively dividing the steep mountains to the west from the vast desert valley to the east. As it provides access to Yosemite National Park via Lee Vining, it passes beneath towering peaks, and past broad desert expanses.

The Mono County Legislative Platform reflects an ongoing commitment by the Board of Supervisors to the visitors and residents of Mono County. The ability of Mono County to serve the people requires support from all levels of government. Both State and Federal Legislative policy and funding decisions affect the County's ability to deliver services. In order to fulfill the County's commitment, Federal and State resources should be sought to support the County's mission. To this end, the County Board of Supervisors supports the priorities and legislative principles set forth below.



## **General Guidelines**

The Mono County Board of Supervisors supports the general guidelines set forth below. County staff will apply these guidelines in evaluating legislation, as well as executive and regulatory actions. It is the Board's objective to implement these guidelines.

To support the County's service to the community, the County should:

- Support legislative and budget efforts that protect and/or enhance local governments revenues, maximize the County's access to state and federal funding sources, and/or increases local funding flexibility;
- Oppose any effort to balance the state budget through the taking of local government resources;
- Support legislation that protects the County's quality of life, its diverse natural resources, and preserves the essence and history of the County;
- Support legislation that provides tax and funding formulas for the equitable distribution of state and federal monies while opposing attempts to decrease, restrict or eliminate County revenue sources;
- Support legislation and budget action which provides additional and continuing funding for local road infrastructure;
- Oppose legislative and administrative actions which would create federal unfunded mandates and/or preempt local decision making authority;
- Support legislation that realigns governmental services in such a manner as to improve the delivery of services and make government more accountable to the people;
- Support the promotion of tourism in the Eastern Sierra in order to achieve economic growth and prosperity;
- Continue to support legislation that honors our veterans for their service to our country;
- Support efforts that further the goals outlined in the County's Strategic Plan (once developed and adopted).

## **State Priorities**

- 1. **Protect County Revenue Sources** Many County programs are at risk due to the instability of State and Federal funding. The Board supports efforts to sustain funding enabling continuation of critical programs for Mono County's constituents.
- 2. **Encourage Regulation Relief/Reform** Given government downsizing at all levels, the Board supports efforts to achieve responsible regulation relief in the following areas:
  - a. California Environmental Quality Act (CEQA) Reform –Support legislative reforms to CEQA to simplify and streamline local permit processing, while still protecting the environment. Examples include clarifying CEQA's fair argument standard that currently enables project opponents to easily trigger costly environmental studies and unnecessary EIRs. Certain exemptions to CEQA should also be extended so they not only apply to urban areas but also to the smaller developed communities more commonly found in rural counties such as Mono.

Efforts to streamline CEQA should include:

- i. Eliminate duplicative layers of regulation between state and federal agencies;
- ii. Single Permit issuance where multiple agencies regulate (i.e. wetlands permit);
- iii. State Involvement in local matters should always be collaborative rather than oversight (I.e. Mines and Geology; Housing and Community Development)

## 3. Natural Resources & Agriculture

- a. **Sustainable Funding for State Parks** Continue to support measures to sustain our State parks for the continued enjoyment of visitors and local residents alike. Closure of these parks would result in a significant negative economic impact on our County as tourism is one of our most important economic drivers.
- b. **Protect our Communities from Forest Fires** Continue to support measures to address forest fire prevention policies and programs in both private and public lands. Continue to seek funding for legislation that supports these goals.
- c. Support Bioenergy Action Plan Mono County supports the ongoing commitment of the California Energy Commission to the 2012 Bioenergy Action Plan, which has resulted in working groups such as the California Biomass Collaborative and legislation like SB 1122. We encourage the various state agencies involved to continue evolving this field of work to produce cleaner, more affordable technology based on sustainable and healthy forestry principles in a manner that benefits rural Sierra economies. In particular, we encourage

state agencies such as the Sierra Nevada Conservancy and California Energy Commission to provide funding for project scoping and planning. Determining a suitable site and the biomass supply that is sustainably available and generating community support is critical to a project's success, but funding for these activities is currently limited.

d. Support legislation that promotes, protects, or facilitates the sustainability of our local agricultural - Mono County agriculture is an important local economic driver, provides jobs, and contributes to the open-space landscape that draws visitors.

## 4. Public Safety & Criminal Justice

- a. Encourage Efforts to Combat Illegal Trespass due to Marijuana Cultivation Instances of illegal trespass and violent crimes on both public and private lands place our residents, visitors, and law enforcement officers at risk. The County will advocate for solutions to stem illegal marijuana cultivation in all areas of the County by working with private property owners, the U.S. Forest Service, the Bureau of Land Management, the California State Board of Forestry and Fire Protection, the California Department of Parks and Recreation, and other regulatory entities to address this problem. The County also supports fines that cover the cost of site clean-up and restoration to mitigate for the impacts to the land, water quality and quantity.
- b. State Realignment & Cost-Shifts Continue to ensure successful implementation of the broad array of programs transferred to county jurisdiction under the 2011 Public Safety Realignment. Including appropriate distribution of AB 109 funding. Support state policy changes that will allow for greater administrative and program flexibility for County programs associated with this shift of responsibility.
- c. **Rural Fire Districts** The population of Mono County is highly rural and dependent upon voluntary associations that provide basic emergency services. These volunteer fire districts provide services to residents, tourists, and are often the first responders to accidents. Support relief for rural fire districts.

## 5. Transportation & Infrastructure

- a. Support legislation and budget action which provides additional and continuing funding for local road and county facility infrastructure.
  - i. Support rehabilitation of Highway 270 Our County economy is based on tourism and one of the main attractions in the Bridgeport area is Bodie State Historical Park. Currently the unpaved section of State

Highway 270 which connects the park to Highway 395 is in disrepair. Many of our county visitors request that the road be paved all the way to the park kiosk. Seek legislation that funds state repairs and paving of State Highway 270 to Bodie as well as ensure funding for ongoing maintenance.

- ii. Support Early Sierra Pass Openings Another main attraction for tourists in the Eastern Sierra is Yosemite National Park. It is vital for Mono County tourism that all trans Sierra passes including Tioga Pass (State Route 120), Sonoma (SR 108) and Monitor (SR 89) are open by Memorial Day, allowing spring holiday travelers access to the park from the eastside. In the past, ensuring timely snow removal has required collaboration between Caltrans, the County and in the case of Highway 120 the Yosemite National Park and the County. Each agency currently provides funding, equipment and personnel for various sections of the road. Seek legislation that ensures State and Park responsibility and timeliness for their sections of the road, allowing county funds to be used for County roads.
- b. Support state resources for county compliance with California Air Resources Board (CARB) Emissions Standards – In order to meet the CARB requirements for improving air quality in California, Mono County will need to replace most of our fleet of heavy duty diesel equipment. Current replacement schedules show this would cost the County around \$21 million over the next 14 years. Support legislation extending the compliance deadline in rural counties for replacement of on-road and off-road heavy duty diesel equipment. Support exemptions for rural counties that do not have the resources to meet regulatory requirements and encourages financial assistance from the State Air Resources Board to foster compliance.

## 6. Administrative & Fiscal Services

- a. Support resources for improving county record keeping services and election administration and monitor legislation that may impact the following:
  - i. 1) recording fees and process, and recorded documents;
  - ii. 2) vital statistic fees and process;
  - iii. 3) public records;
  - iv. 4) unfunded mandates;
  - v. 5) vote-by-mail, voter registration, election management systems, elections process, and election equipment.
- b. **Support Williamson Act Funding** The State of California has eliminated funding for the Williamson Act (the California Land Conservation Act). Mono County, like

most other rural counties, is dependent on State funding to offset the loss of property tax revenue to the County. This program has been hugely beneficial to our agricultural county. Support legislation and budget language that seeks full funding of the Williamson Act.

c. Support the full funding of all Payment in Lieu of Taxes (PILT) - Support legislation and budget efforts that continue to maximize the PILT revenue from the federal and state government to counties and continues full funding of PILT without restrictions beyond the current authorization.

## 7. Health & Human Services

- a. Ensure State and Federal Healthcare Reform has equitable funding formula for rural counties - In 2014, Implementation of Affordable Care Act (ACA) will begin, it is vital that local government funding streams reflect equitable distribution formulas to service our rural constituents. Securing adequate funding to sustain health care reform measures is important to Mono County. Key issues include:
  - i. Medi-Cal expansion and funding for these mandates
  - ii. The 1991 Realignment allocation/amounts

## **Federal Priorities**

- 1. **Support Funding/Program Preservation** Support legislative, regulatory and budget efforts that protect and/or enhance local governments' revenues, maximize the County's access to federal funding sources, and/or increase local funding flexibility.
  - a. Oppose Federal unfunded mandates and/or preempt local decision-making authority
  - b. Ensure Affordable Care Act (ACA) funding maintained for local governments Support the Prevention and Public Health Fund of the ACA, the nation's first dedicated mandatory funding stream for public health and prevention activities, which support Mono County health care services to underserved residents.
  - c. Support federal funding for Housing and Economic Development Programs support the highest possible funding level for key federal housing and economic development programs, including the Community Development Block Grant (CDBG).
  - d. Support local efforts to develop alternative energy sources including but not limited to biomass, solar, wind and geothermal power generation.
  - e. Support funding for Broadband Deployment through the funding of infrastructure projects and grant programs, allocation of resources to broadband planning, advisory, or support oriented organizations Mono County is a rural California county in which most of our communities and constituents lack access to high-speed Internet. Though improving in the region through the Digital 395 Project, Mono County communities and residents still face barriers to connectivity. Having access to federal funds is critical, as infrastructure projects in much of the area are typically cost prohibitive, and do not yield a significant enough return based on the small population.
  - f. Support legislation that promotes, protects, or facilitates the sustainability of our local agricultural - Mono County agriculture is an important local economic driver, provides jobs, and contributes to the open-space landscape that draws visitors.
  - g. Support Economic Development Resources
    - i. Support H.R. 1241, an act to facilitate a land exchange at the base of Mammoth Mountain Ski Area - The vitality of Mammoth Mountain will have substantial beneficial economic effects on the Eastern Sierra region and Mono County, including increased property tax and transient

- occupancy tax revenues, increased regional visitation, and direct and indirect job creation.
- ii. Ensure access to federal public lands which support tourism
- iii. Maintain and support access to small business capital for local business development through the Small Business Administration.
- iv. Support the funding of efforts to bolster fishing and other recreational activities such as funding for the Lahonton Trout Program.
- 2. **Natural Resources & Agriculture** Support legislation that ensures public access to local natural resources and agriculture throughout the County.
  - a. **Support Forest Fuels Reduction and Management Efforts** with 94% of Mono County publically owned, much of which is covered with high fuel loads, fuels reduction is a major concern for Mono County and its communities. Continue to seek funding priority fuel reduction projects around Mono County communities and key tourist resources through local fire safe councils and public agencies.
  - b. Support control and mitigation for the spread of invasive species to protect, conserve and restore public and private lands
  - c. **Support Biomass Project Development** Support legislation that encourages the US Forest Service (USFS) to continue actively promoting and assisting with biomass project development. For instance, the Woody Biomass Utilization Grant is critical to funding engineering and design for a somewhat high-risk venture, and is directly related to the USFS's multiple-use mission which requires healthy forests.
- 3. Endangered Species Support a balanced approach of the implementation of endangered species regulation with impacts to the economy and communities of Mono County. Mono County is fortunate to have a rich natural heritage which should be conserved, and supports the need to protect and recover imperiled species. At the same time, these conservation measures must be weighed and balanced against impacts to the fragile rural economy and local communities, and every effort must be made to protect private property rights and avoid detrimental impacts to County residents. The species below only include those known or anticipated to be listed, and any other listings that may arise should be analyzed carefully.
  - a. Minimize local impacts that result from Yellow Legged Frog and Yosemite Toad Listing and Critical Habitat Designation Ensure critical habitat and the threats to the Sierra Nevada yellow-legged frog and Yosemite toad are correctly identified to stop the precipitous decline of these species and support their

eventual recovery while minimizing impacts to the economy and communities of Mono County.

- b. Oppose Proposed Sage-Grouse Listing under the Endangered Species Act (ESA)

   Support continued participation by federal agencies in a collaborative process to address Bi-State Sage-Grouse listing and conservation efforts. A current USFWS listing proposal recommends over 82% of our small private land base to be included within critical habitat for the sage-grouse.
- c. Monitor Western Yellow-billed Cuckoo listing process- Mono County is not impacted by the Service's current proposal to list the cuckoo as a threatened species. Found in counties to the north, west and south of Mono County, the potential exists that the County could be impacted by a future critical habitat designation proposal.
- d. Monitor American Wolverine & Pacific Fisher listing process Proposals are anticipated for these two species that currently and/or historically occurred in Mono County, based on the list of species from a July 2011 legal settlement between the Service and the Center for Biological Diversity. The settlement requires the Service to make listing determinations for 757 species by 2018.

#### 4. Public Safety & Criminal Justice

a. Support full funding of Byrne Justice Assistance Grants – Support the preservation of funding levels for existing safety programs such as the Byrne Justice Assistance Grant (Byrne/JAG) Program and oppose efforts to reduce or divert funding away from these programs.

### 5. Transportation & Infrastructure

- a. Ensure federal transportation formulas support rural road infrastructure Mono County has concerns regarding the continued implementation of the federal surface transportation reauthorization program, known as the Moving Ahead for Progress in the 21<sup>st</sup> Century Act or MAP-21. Mono County relies on the network of state highways and locally maintained roads to link residents to essential services. Transportation funding formulas should provide funding protections or guarantees for California's rural transportation system and reflect that rural counties lack viable means to fund larger projects that provide statewide benefit. We should advocate for formulas that distribute federal funds to support local transportation priorities.
- b. Support efforts to protect the Highway Trust Fund and support programs that provide funding for local roads, bridges, and transit initiatives including pedestrian and bicycle systems.

#### RECOMMENDED ACTION

Approve Resolution R13-\_\_\_, accepting the Planning Commission's recommendation and Addendum 13-04 to the Mono County General Plan EIR and approving General Plan Amendment 13-004.

#### **BACKGROUND**

The Board of Supervisors approved General Plan Amendment 12-001 in December 2012 that added Chapter 25, Transient Overlay Districts, and Chapter 26, Transient Rental Standards and Enforcement, to the Mono County General Plan Land Use Element. The intent of the amendment was to allow transient rentals within compatible residential neighborhoods to increase tourism opportunities and provide additional economic support to homeowners.

The creation of Chapters 25 & 26 provides a General Plan tool to allow transient rentals in specific neighborhoods through a General Plan Amendment application for a Transient Rental Overlay District (TROD).

A TROD application requires that the shape of any proposed district be contiguous, compact and orderly. Factors used to determine compact and orderly include street-frontage sharing, adjoining yards, and existing characteristics that define residential neighborhood boundaries such as subdivision boundaries, major roads, natural features, large undeveloped parcels and commercial or civic land uses.

Chapter 26 provides regulations that ensure transient rentals meet minimum safety requirements, provide 24-hour local property management, allow for enhanced enforcement of unpermitted transient operators, and provide means for minimizing potential neighborhood conflicts such as parking and noise. If a Transient Rental Overlay District is approved, individual homeowners in the district would then be required to submit a Transient Rental application in conformance with the regulations specified in Chapter 26 before commencing short-term rentals.

#### **GENERAL PLAN AMENDMENT 13-004**

The proposed Transient Rental Overlay District (TROD) is located along Boulder Drive in June Lake and includes four parcels: APNs 015-140-035, -034, -033, & -032. Each has an existing single family residence. Surrounding land uses are primarily single-family homes, however parcels across the street from the proposed district have a land use designation of Commercial Lodging, high.

Following the Planning Commission hearing notice, adjoining neighbors called with concerns and questions regarding the creation of a TROD. Most all concerns seemed to have been satisfied after reviewing and clarifying the TROD-related General Plan chapters. To date, no formal comment letters have been received. Any comments received after the Planning Commission packet has been distributed will be provided and included as part of the record at the hearing.

# **Project Location**



#### LAND DEVELOPMENT TECHNICAL ADVISORY COMMITTEE

The LDTAC met August 19, 2013, to review and provide input on the project proposal. The LDTAC accepted the proposed Transient Rental Overlay District application and recommended moving forward with processing the permit.

#### PLANNING COMMISSION

The Planning Commission considered the item at a public hearing on November 14, 2013. No Members of the public spoke in opposition of the project. The Planning Commission subsequently adopted Resolution 12-07 (see attachment) recommending acceptance of the EIR Addendum and that the Board of Supervisors approve GPA 13-004. The Board of Supervisors is required to consider the Planning Commission recommendation at the public hearing and may approve, modify or disapprove the recommendation.

#### **GENERAL PLAN CONSISTENCY**

The proposed general plan amendment complies with existing General Plan, Countywide Policies: **Objective H** Maintain and enhance the local economy.

Policy 5: Promote diversification and continued growth of the county's economic base.

*Action 5.1:* Encourage and promote the preservation and expansion of the county's tourist and recreation based economy.

The project provides for additional visitor lodging and encourages tourism by providing a variety of lodging options and is consistent with the text and maps of the General Plan and June Lake Area Plan.

### **CEQA COMPLIANCE**

An addendum to the county General Plan EIR has been prepared for the proposed project. The impacts of the proposed project will not result in a substantive change to the number of significant effects, severity of

effects, or the feasibility and/or effectiveness of applicable mitigation measures or alternatives previously addressed in the General Plan  $\rm EIR$ .

### INTRODUCTION AND DISCUSSION OF PROPOSED MODIFICATIONS

### 1. Transient Overlay Districts

Mono County has received applications to amend the General Plan Land Use Designation Maps to establish a Transient Rental Overlay District (TROD) to allow for nightly rentals. GPA 13-004 would establish a TROD on four parcels (APNs 015-140-035, -34, -33, -32) along Boulder Drive at June Lake.

A Vacation Home Rental Permit will be required in accordance with Chapter 26 of the Mono County General Plan before commencing rentals of any dwellings. Vacation Home Rental Permits will address and regulate traffic and parking, guide tenant occupancy, establish minimum health and safety requirements, and require 24-hour property management, among other things.

# ENVIRONMENTAL REVIEW & CEQA PROVISIONS FOR PREPARATION OF AN ADDENDUM TO A FINAL EIR

In 2001, Mono County certified an Environmental Impact Report (EIR) in conjunction with the adoption/amendment of its General Plan (SCH # 98122016) (the "General Plan EIR"). The General Plan EIR analyzed the impacts of designating areas of the county as SFR, ER, RR, or RMH, and assumed full buildout and use of those properties for all allowed uses. It also addressed and analyzed the impacts associated with the development of accessory dwelling units. As discussed below, an addendum to the General Plan EIR is the appropriate level of environmental review for the proposed amendments, because none of the conditions set forth in CEQA Guidelines section 15162 exist.

The California Environmental Quality Act (CEQA §15164[a]) states:

"(a) The lead agency or a responsible agency shall prepare an addendum to a previously certified EIR if some changes or additions are necessary but none of the conditions described in Section 15162 calling for preparation of a subsequent EIR have occurred."

In turn, §15162 states that preparation of a subsequent EIR is required where one or more of the following occurs:

- "(a) When an EIR has been certified or a negative declaration adopted for a project, no subsequent EIR shall be prepared for that project unless the lead agency determines, on the basis of substantial evidence in the light of the whole record, one or more of the following:
  - (1) Substantial changes are proposed in the project which will require major revisions of the previous EIR or negative declaration due to the involvement of new significant environmental effects or a substantial increase in the severity of previously identified significant effects;
  - (2) Substantial changes occur with respect to the circumstances under which the project is undertaken which will require major revisions of the previous EIR or negative declaration due to the involvement of new significant environmental effects or a substantial increase in the severity of previously identified significant effects; or

- (3) New information of substantial importance, which was not known and could not have been known with the exercise of reasonable diligence at the time the previous EIR was certified as complete shows any of the following:
  - (A) the project will have one or more significant effects not discussed in the previous EIR or negative declaration;
  - (B) significant effects previously examined will be substantially more severe than shown in the previous EIR;
  - (C) mitigation measures or alternatives previously found not to be feasible would in fact be feasible, and would substantially reduce one or more significant effects of the project, but the project proponents decline to adopt the mitigation measure or alternative; or
  - (D) mitigation measures or alternatives which are considerably different from those analyzed in the previous EIR would substantially reduce one or more significant effects on the environment, but the project proponents decline to adopt the mitigation measure or alternative."

### **DISCUSSION OF IMPACTS**

Establishing Transit Rental Overlay Districts that would allow nightly rentals proposed in the aforementioned residential areas (the "Project") does not require major revisions to the General Plan EIR because it does not involve new significant environmental effects or a substantial increase in the severity of previously identified significant effects; there are not substantial changes with respect to the circumstances under which the project is undertaken; and there is not new information of substantial importance, which was not known and could not have been known with the exercise of due diligence at the time the previous EIR was certified as complete which shows any of the following listed above under headings (3) (A) through (3) (D), for the following reasons:

- 1. The proposed Transient Rental Overlay Districts will not have a significant effect on the environment or increase the severity of previously identified significant effects. The overlay district in June Lake consists of four adjoining lots. The creation of a Transient Rental Overlay District (enables short-term rentals) but does not expand the types of structures allowed or the manner in which the vacant parcels can be developed in the future. Future development will be limited to the residential densities established in the underlying land use designation. Additionally, General Plan Land Use Element Chapter 26 further governs how transient rentals are to be conducted, which places much-more-stringent regulations on rentals than that of a home occupied by a full-time resident.
- 2. Additionally, even following designation and permitting for transient rental use, there is no change to the underlying property use. Single-family homes that are now used seasonally or periodically by the owner, or are rented on a long-term basis, will still be used as single-family homes and in a manner that is not substantially different from how they would be used if they were occupied by full-time residents or long-term renters. The General Plan EIR analyzed land use designations at buildout assuming full-time occupancy. Since there is virtually no difference in the use of a home being occupied by a full-time resident and its use by household that rents the home on a short-term basis, the environmental impacts to the neighborhood and surrounding areas are no different. Transient rentals, due to the intermittent and temporary nature of their use, will not create any additional impacts on traffic or air and water quality. Furthermore, since the occupancy and parking will be much more narrowly regulated by a required property manager, the impacts on noise and street congestion will also be reduced. Accordingly, the impacts of the proposed project would not be increased beyond those analyzed in the General Plan EIR.

- 3. The establishment of Transient Rental Overlay Districts creates the possibility of a reduction in environmental impacts that exist at present, since transient uses would be subject to more-stringent restrictions than are applicable to full-time owner-occupied residences or residences subject to long-term lease. Specifically, these include restrictions on occupancy, parking and the requirement for oversight through local property management. Currently, there are no restrictions on how many occupants can use a single-family home, but the occupancy in homes used as transient rentals will be restricted by the number of bedrooms and/or any septic system limitations. Parking requirements will be site specific and not only will have to meet the General Plan residential parking standards, but will be limited to on-site parking only. These measures in conjunction with local property management being available 24 hours to regulate noncompliant activities of tenants will minimize visual and noise impacts far beyond residences having full-time occupancy.
- 4. The change to the regulations affecting the size and permitting requirements of accessory dwelling units will not cause an environmental impact. The change reduces the potential intensity of allowed development and environmental impacts on parcels less than one acre in size.

### **CONCLUSION**

CEQA Sections 15164(c) through 15164(e) states, "An Addendum need not be circulated for public review but can be included in or attached to the final EIR or adopted negative declaration. The decision-making body shall consider the addendum with the final EIR or adopted negative declaration prior to making a decision on the project. A brief explanation of the decision not to prepare a subsequent EIR pursuant to §15162 shall be included in an addendum to an EIR, the lead agency's findings on the project, or elsewhere in the record. The explanation must be supported by substantial evidence."

The information presented above indicates that the proposed General Plan Amendment does not represent a substantive change to the number of significant effects, severity of effects, or the feasibility and/or effectiveness of applicable mitigation measures or alternatives previously addressed in the General Plan EIR. Therefore, a subsequent EIR is not required because none of the conditions set forth in CEQA Guidelines section 15162 exist for this project.

**WHEREAS**, the Mono County Planning Commission did, on November 14, 2013, hold a noticed and advertised public hearing to hear all testimony relevant to the General Plan Amendment, and upon conclusion of the hearing, recommended via resolution that the proposed transient rental overlay district be approved by the Mono County Board of Supervisors.

NOW, THEREFORE, BE IT FURTHER RESOLVED THAT, having considered the environmental addendum and taken into consideration all evidence and testimony before it, including the recommendation of the Planning Commission, the Mono County Board of Supervisors, in conformance with the Mono County General Plan, Chapter 48, Section 48.020, hereby: (1) approves Addendum 13-04 to the to the Mono County General Plan EIR; (2) finds that General Plan Amendment 13-004 is consistent with the General Plan; and (3) approves General Plan Amendment 13-004 adding a Transient Rental Overlay District to Assessor's Parcel Numbers 015-140-035, -34, -33, -32.

A RESOLUTION OF THE MONO COUNTY PLANNING COMMISSION RECOMMENDING APPROVAL OF GENERAL PLAN AMENDMENT 13-004, PLACING A TRANSIENT RENTAL OVERLAY DISTRICT ON FOUR ADJOINING PARCELS AT JUNE LAKE (ASSESSOR'S PARCEL NUMBERS 015-140-035, -34, -33, -32)

WHEREAS, In accordance with General Plan Requirements, the property owners have submitted a Transient Rental Overlay District application for a transient rental, which includes a General Plan Map Amendment (GPA); and

WHEREAS, the proposed General Plan Amendment 13-004, in conjunction with a Vacation Home Rental Permit, will allow the owners of Assessor's Parcel Numbers (APN) 015-140-035, -34, -33, -32 to rent out Single-Family Residential homes on a transient or nightly basis; and

WHEREAS, pursuant to the California Environmental Quality Act (CEQA) an Addendum to the Mono County General Plan EIR pursuant to CEQA section 15164 has been prepared; and

**WHEREAS,** the Planning Commission did on November 14, 2013, hold a noticed and advertised public hearing to hear all testimony relevant to the General Plan Amendment.

**NOW, THEREFORE, BE IT RESOLVED THAT,** in consideration of evidence and testimony presented at the public hearing and in accordance with Chapter 48 of the Land Use Element of the General Plan, the Planning Commission finds as follows with respect to the proposed GPA:

1. The proposed change in the land use designation is consistent with the text and maps of this General Plan.

The project promotes the following General Plan's countywide policies: Objective D states the County should provide for commercial development to serve both visitors and residents; Policy 4 allows for the integration of small-scale commercial uses with associated residential uses; Objective H maintains and enhances the local economy; and Action 5.1 encourages and promotes the preservation and expansion of the county's tourist and recreation-based economy. The project provides for additional visitor lodging and encourages tourist-based economy and is consistent with the text and maps of the General Plan.

2. The proposed change in land use designation is consistent with the goals and policies contained within any applicable area plan.

The project is located within the June Lake Planning Area and is in close proximity to other established lodging facilities. The June Lake Area Plan encourages providing a wide range of commercial and residential uses. The project provides for additional visitor lodging for the tourist-based economy by providing a variety of lodging options within the June Lake Loop.

3. The site of the proposed change in land use designation is suitable for any of the land uses permitted within that proposed land use designation.

The project is not changing the underlying land use designation of Single-Family Residential (SFR), but is adding a Transient Rental Overlay District that will allow the addition of nightly rentals only in single-family dwellings. Chapter 25 in the Mono County General Plan allows

Transient Rental Overlay Districts to be applied to the SFR, RR, ER, MFR-L, and RMH land use designations. Chapter 26 in the Mono County General Plan requires that any homes being rented within the overlay district obtain a Vacation Home Rental Permit that will regulate parking, guide tenant occupancy, establish minimum health and safety requirements, and require 24-hour property management, among other things.

- 4. The proposed change in land use designation is reasonable and beneficial at this time. The proposed change to add a Transient Rental Overlay District is reasonable because of the close proximity to other lodging establishments and is beneficial to the community's visitor-oriented economy by expanding the variety of lodging options within June Lake.
- 5. The proposed change in land use designation will not have a substantial adverse effect on surrounding properties.

The application of Transient Rental Overlay District on Assessor's Parcel Numbers 015-140-035, -34, -33, -32 will not create undue hardship on adjacent properties. Single-family homes that are used seasonally or periodically by the owner, or are rented on a long-term basis, will still be used as single-family homes and in a manner that is not substantially different from how they would be used if they were occupied by full-time residents or long-term renters. The General Plan EIR analyzed land use designations at buildout assuming full-time occupancy. Transient rentals will have similar visual characteristics as a home having seasonal or full-time occupancy. Furthermore, homes used as rentals within the district are subject to more-stringent restrictions than applicable to full time owner-occupied residences or residences subject to long-term lease. Specifically, these include restrictions on occupancy based on the number of bedrooms, parking and the requirement for oversight through local property management. These measures in conjunction with local property management being available 24 hours to regulate non-compliant activities of tenants will minimize visual and noise impacts far beyond residences having full-time occupancy. Moreover, Chapter 26 in the General Plan provides enhanced enforcement mechanisms to prevent non-permitted or unauthorized transient rentals within residential zones.

NOW, THEREFORE, BE IT FURTHER RESOLVED THAT, having considered the environmental addendum and taken into consideration all evidence and testimony before it, the Mono County Planning Commission, in conformance with the Mono County General Plan, Chapter 48, Section 48.020, hereby finds that the proposed changes are consistent with the General Plan and recommends that the Board of Supervisors approve General Plan Amendment 13-004 adding a Transient Rental Overlay District to Assessor's Parcel Numbers 015-140-035, -34, -33, -32.

#### **Background**

The Mono County Board of Supervisors beginning in January of 2013 recognized the need for focused long term focused planning to martial scarce county resources addressing growing long term issues facing the County. The Board held five public sessions to identify issues. This process continued into the Fiscal Year 2013-2014 Budget process where additional issues and concerns where identified.

Strategic Planning is a process which focuses an organization on long-term issues, establishes clear purpose for all staff and produces a system of results oriented measurement that reinforces how best to use scarce resources for maximum return., As resources have diminished over the last 15 years and more dramatically in the last 6, Strategic Planning has given the public and policy makers the ability to focus not merely on the next year but the next five, ten and twenty years, and build an effective understanding of services and the necessary focused investment for service improvement.

Effective Strategic Planning goes beyond identifying and completing tasks but changes how we do business at the County and provides new methods to engage our employees in building a Higher Performing Organization. It builds context for all operations.

The item before the Board is a proposed process which will launch a robust, intense and required Planning process and is designed to develop, implement and drive the organization built upon a Strategic Plan.

## **Background**

Strategic planning is a process which focuses an organization on long-term issues, establishes clear purpose for all staff and produces a system of results oriented measurement that reinforces how best to use scarce resources for maximum return. In local governments, as resources have diminished over the last 15 years and more dramatically in the last 6, Strategic Planning has given the public and policy makers the ability to focus not merely on the next year but the next five, ten and twenty years, build an effective understanding of services and focused investment on service improvement.

Effective strategic planning goes beyond identifying and completing tasks but changes how we do business at the County and provides new methods to engage our employees in building a Higher Performing Organization. It builds context for all operations.

Local governments across California, including Mono County, have seen a growing imbalance of resources and responsibilities. As state and federal governments have shifted responsibility for service delivery and reduced overall resources, counties have seen growing financial pressures. This shift, coupled with reductions in local revenues (such as property taxes, local sales and tourism taxes), has made the ability of the County to plan for the long term difficult. As counties deliver or provide 75% of all services that constituents receive, the budgeting process has become a triage from year to year, being dependent on the next economic bubble.

It is customary for private and other public agencies to utilize the strategic planning process. The lack of resources, the lack of clarity of purpose and the increasing expectation of the public for services require us to follow suit.

Mono County faces a series of long-term liabilities and reduced resources to address them. In addition, the Board has identified a number of community issues which also need focus. The County long term liabilities and issues were touched upon during the 2013-2014 FY Budget Hearings. They are detailed in Attachment A – Table of Liabilities from Budget 2013-2014 hearings. The Board through five public sessions created a series of projects (Attachment B) which reflected short, medium and long term issues the County must also address.

A process to coalesce all of these elements and issues together into one cohesive plan is before the Board today. The development, refinement and adoption of a Strategic Plan will provide an evolving road map for the next five, ten and 20 years. It must be a living document built with the employees, public and the Board which creates a direction to guide decisions and focus resources on the most important needs. It will never be complete as issues and circumstances change but it must be absolute in its target of the long term challenges.

Strategic planning supports broader education and understanding by the public of what counties do and why, helps employees improve the services they provide and allows policy makers to have measurable results to guide future policy decisions. It will not be quick, easy or simple and requires discipline and commitment to be successful. When the County

has developed and launched a Strategic Plan, County liabilities and the projects identified should have a place within the plan and should be prioritized. Future issues that arise will be viewed thru a lens for guiding where scarce resources go. As there are limited resources, there will be some things which are not funded.

Good strategic planning takes time, commitment and involvement from all parts of the organization. As an organization moves through the process, the end result will focus what we are doing and why.

A strategic plan is not a one-time project, but a system an organization adopts and commits to, wherein it constantly reviews, measures and improves services and prioritizes where it commits resources.

There are key components to a strategic plan:

- Vision Where are we going and what will we be when we get there?
- Mission what is our purpose, our reason for existing?
- Goals What are we going to achieve and how?
- Values What motivates our service? What Principles do we live by?
- Results How will we measure success?

For Mono County which has been impacted by the feast and famine of outside economic forces, inconsistent weather patterns and a county where over 94% of the land is controlled by federal and state agencies, some guiding questions include:

- 1. Where are we going?
- 2. Who do we want to be?
- 3. How will we provide the best services that matter most to our residents and visitors?
- 4. How are we accountable for service delivery?
- 5. How will we know success?

The following proposal reflects the first needed step to the process. It includes a process timeline, constituencies, and methods for engaging people in this process. It will take time and be an exercise in engaging and listening to constituents, creating options, weighing choices and choosing a path. Once a full Strategic Plan is adopted, we can use it to guide our budgets, focus and measure service improvement and invest in Mono County. The strategic planning process will help us tp create our future as Mono County, the future we all desire.
