#### **Recommendation:**

Adopt resolution determining that Raymond Tems is eligible for Industrial Disability Retirement. Provide any desired direction to staff.

#### Fiscal/Mandates Impact:

Advance Disability Pension payments in the amount of \$4,093.75 per month until the determination is final with CalPERS, at which time said expenditures would be reimbursed to the County.

#### Discussion:

CalPERS requires a Board determination regarding the County's position on the disability, or lack thereof, of an employee filing for an industrial disability retirement (IDR). In this case, medical evaluations and reports conclusively establish that Mr. Tems' injury prevents him from carrying out his normal duties in the Sheriff's department for the indefinite future, and the County previously agreed that the injury was work-related through the worker's compensation process. As such, it is appropriate to make the formal finding that he is substantially disabled for purposes of his IDR application

#### A RESOLUTION OF THE MONO COUNTY BOARD OF SUPERVISORS DETERMINING THAT RAYMOND TEMS IS ELIGIBLE FOR INDUSTRIAL DISABILITY RETIREMENT

**WHEREAS**, the County of Mono (hereinafter referred to as Agency) is a contracting agency of the Pubic Employee's Retirement System; and

WHEREAS, the Public Employee's Retirement Law requires that a contracting agency determine whether an employee of such agency in employment in which he is classified as a local safety member is disabled for purposes of the California Public Employee's Retirement Law and whether such disability is "industrial" within the meaning of such Law; and

**WHEREAS,** an application for industrial disability retirement of Raymond Tems employed by the Agency in the position of Undersheriff has been filed with the California Public Employee's Retirement System; and

**WHEREAS**, the County of Mono has reviewed the medical and other evidence relevant to such alleged disability;

# NOW, THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF MONO RESOLVES that:

- 1. That the County of Mono does hereby find and determine that Raymond Tems is substantially incapacitated within the meaning of the California Public Employee's Retirement Law for performance of his duties in the position of Deputy Sheriff.
- 2. That County of Mono does hereby find and determine that such disability is a result of injury or disease arising out of and in the course of employment. Neither said Raymond Tems nor the agency, County of Mono, has applied to the Workers' Compensation Appeals Board for a determination pursuant to Government Code section 21166 whether such disability is industrial.
- 3. That the member was separated from his employment in the position of Deputy Sheriff after expiration of his rights under Government Code section 21164, effective November 3, 2015 and no dispute as to the expiration of such leave rights is pending. His last day on pay status is November 3, 2015.
  - 4. There is not a possibility of third party liability.

#### **SUBJECT:**

This will be a workshop regarding the 71 Davison Project in Mammoth Lakes. The Davison House is a resource for Mono County to provide Permanent Supportive Housing to residents in our county who are the most vulnerable. Research confirms that providing a safe, treatment centered environment to those who struggle with mental health issues is not only cost effective, but also increases the efficacy of treatment and provides the potential for those with mental illness to live productive, purpose driven, healthier lives. Combining treatment as well as life and job skills for those who are re-entering society though our justice system is shown to reduce recidivism.

#### **RECOMMENDED ACTION:**

Hear presentation followed by discussion and provide direction to staff.

#### **DISCUSSION:**

From 1987 to 2011 Mono County Behavioral Health has used 71 Davison House to provide housing for those with serious mental health illness; including Substance Use Disorders. In 2011 it was closed down in an attempt to sell the property, which did not occur. It has been vacant since. Through Mental Health Services Act (MHSA) funding, Mono County Behavioral Health has the capacity to renovate and re-open 71 Davison. Davison will become Permanent Supportive Housing, with onsite 24/7 staff, for residents of Mono County who have mental health issues, are homeless or at risk of homelessness, and who would benefit from a prosocial, treatment centered environment.

The Davison House will also serve those who are designated by our justice system as meeting criteria for Permanent Supportive Housing in order to facilitate their success with re-entry into society.

MCBH will also provide treatment services (individual and group) to all residents; including psychiatry, psychotherapy, Substance Use treatment, case management, education support, employment support, general living skills, etc. Through our partnerships with county and community organizations, residents will be linked to medical care, job training, community service opportunities, educational institutions, and the like.

#### STRATEGIC PLAN:

This project has the support of the CAO, Mono County Sheriff, Mono County Probation Department, Mono County District Attorney, Director of Public Health, Director of Social Services, and other county and community departments. It fits within the following Strategic Goals: Understand and Address Community Needs & Support Healthy People in Healthy Communities. Effective Use of Resources by providing supportive housing to those who might otherwise be homeless and providing services to those who might otherwise not be able to engage for the full benefit; Strengthening County Culture by providing necessary services and housing to those who are most vulnerable.

#### **FISCAL IMPACT:**

There is no fiscal impact to the Mono County General Fund.

This project will be funded by Mono County Behavioral Health through MHSA funding. This project will be maintained through Mono County Behavioral Health funding as well as through grants and the Community Correction Partnership.
