Dear Mono County Supervisors -

If Humboldt-Toiyabe National Forest can **ban ALL campfires** (including those in fire rings at established campgrounds) - why can't Inyo National Forest? Fire danger is extreme right now, and state firefighting resources are stretched beyond capacity. A forest or brush fire in the Mammoth Lakes region could get out of control very quickly. Imagine thousands of bonfires being lit within a matter of minutes with the thousands of slash piles from forest thinning that are present in the Mammoth Lakes Basin and near the Scenic Loop Road (not to mention all of the dead trees still standing).

We are very lucky the town hasn't burned down this summer, with the hoards of visitors that don't have a clue about fire safety and all of the illegal campfires from dispersed campers near town.

Driving to Duck Pass trailhead I've seen abandoned campfires in Coldwater Creek Campground more than once. I put the fires out with a shovel I carry in my car. No camp hosts present to put out the fires.

A ban on ALL campfires could be stated on Caltrans message boards throughout the county, and well as additional banners and signs. Keep the message simple.
