Dear Mono County Board of Supervisors, Dr. Tom Boo, and Economic Development,

We own the Crowley Lake RV/Mobile Home Park in Crowley Lake. Due to the Mono County Health Department's Mono Gram short term rentals restriction dated March 21, 2020, we have canceled and refunded all upcoming reservations through May 31, 2020. We understand the initial response to the pandemic, and we have complied with this order out of respect for authority and an abundance of caution. Although Mono County's restriction complies with Governor Newsom's Stay at Home Order (N-33-20), we are only meant to "heed" this order. The State of California and Mono County do not have the authority to deem any business non-essential or quarantine healthy people. This drastic order is simply unconstitutional and violates our freedoms. This order has resulted in an extreme loss of revenue for our business and our tenants. Our business has maintained our employees, yet we have not been able to secure any funding from the Federal Government even though we have applied through several banks in a timely manner. We are asking you to highly consider ceasing this order immediately, not only for our business but for our tenants as well. Please allow us to exercise our freedoms and open our business in compliance with social distancing.

We have seen the numbers decreasing; and if we do not open soon, there will not be many small businesses left standing in our county. Many other small business owners are struggling to get through this. Our county thrives on tourism, and you all have effectively and unlawfully taken that from all of us. Decisions continue to be made that are "for the health" of our citizens, but health alone does not justify these harsh closures. We will not be able to feed and care for our families if we do not have tourism dollars in this county. The longer we postpone reopening, the harder it is going to be for all of us to recover from this. One by one, small businesses are going under because of the prolonged closure decisions made by the Board of Supervisors, Dr. Boo, Mammoth Hospital, and especially the State of California.

We are very concerned about our full-time tenants that live and work in our community. These closures have created severe hardships. Although we continue to offer inexpensive space rent in Mono County, our tenants are finding it increasingly difficult to pay as they have all been laid off from their jobs. Unemployment will only sustain them for a short period of time. Regardless if our tenants are able to pay or not, we are still required by law to cover living expenses such as

electricity, water, propane, trash, sewer and required maintenance of the grounds. This has and will continue to create a severe financial hardship on our business and family.

Additionally, we are disheartened that Mammoth Parks and Rec has already canceled summer programming. Canceling programs that benefit our youth is a shame. If our Covid-19 cases continue to decline, why are our children not allowed to participate in camps with other local children? This is simply irrational. Furthermore, now that the Crowley Lake Fireworks Show is canceled, we will be seeing a drastic drop in revenue for the year. Our 4th of July celebration brings tourism dollars to our county, and now, you have taken that away as well. You have closed our skateparks and our community parks. Our taxpayer dollars fund the maintenance of these parks and facilities, yet we have not had access to these for over 6 weeks. These are extreme decisions, and the numbers of Covid-19 cases do not warrant these draconian measures.

Please understand that we are fully aware of why these closures were initially put into place. We have done our part to flatten the curve; and as we continue to research this, we see that we have successfully accomplished this goal. It is now time to allow our small businesses and tenants an opportunity to recover by beginning to reopen. We understand that our county reopening will look quite a bit different given the situation, but at least our businesses and locals may have a fighting chance. We urge you to follow the science and reopen our county.

Please do not write Washington DC and advocate they shut down our forests like they have in other states that have much worse scenario than we do. Eastern Sierra California has shown we are responsible and able to keep our communities healthy ~ especially the Eastern Sierra. We can as a community beat this and keep our Forest Service Public Lands open. We are not like other states and need not act in fear. Act with awareness yes, to act in fear no.

Now this is changing with LAWP closing many of our well loved country roads and access is getting smaller and smaller. Yet people are not climbing, we are not back country skiing or snowboarding and we are social distancing well in public lands. Those that do understand they must be safe as well as responsible~ the community shaming for extreme sports is understood. Supporting search and rescue and our hospitals is well understood.

We are used to climbing in LAWP's crags, or enjoying the cold springs yet we wait, almost expecting them to close, and they do one by one. We receive this health in the clear blue rivers, lakes and streams of our mountains. Please don't make us wait for them too in the heat of the summer while we already sacrificed our best winter days turned into sweetest spring corn. In BLM's wild open free vast landscapes we find freedom, peace of mind and health and it is understandable that the hot springs are closed... This is enough. Please keep our National Forest Public Lands open. And I mean this in that we have respected the rules and kept visitors at bay with kindness.
