

Improve safety in all of Mono County Infrastructure



# Engineering -Duties

- Engineering work for all departments and Divisions in Mono County
- Engineering and Surveying review of private work
- Pavement Management system work to support our road system
- Local, State and Federal compliance with spill prevention, water quality and air quality
- Project development and management for Road and infrastructure development
- Airport and Cemetery Management
- Management of Millions of dollars annually for the maintenance of Road and infrastructure funding sources
- Acquisition of Grants and funding for Road Improvements
  - Completed examples include Upper Rock Creek Road and Convict Lake Road. Also upcoming will be Saddlebag Road project for 12 million dollars.
- Begin process toward new Medic 7 building

#### Roads - Duties

- Maintain 679 miles of roadways
  - Winter
    - Snow Removal
    - Avalanche Preparedness
    - Closures
  - Summer
    - Grading of the Dirt Roads
    - Maintenance Crack Gap Seal, striping, etc
    - Mowing
    - Signage Snow Poles
- Special Events (Board Item)
- DOT driving requirements
- Mineral Site Reporting

Roads Projects and Tasks

- Open Virginia Lakes Road and Upper Rock Creek Road
- Monitor and fix mud and rock slides.
- Fix shoulders where they have washed out
- Probably agreement with USFS for Fuel reduction work
- Spring Crack fill and striping work
- Snow removal
- Special events and Road Closures
- Contracts for outside road repairs
- Keep equipment moving


# Solid Waste - Responsibilities

#### Solid Waste - Duties





Management of Parcel fees, Tipping Fees, commodity sales

Site Audits



Conform to state Laws and diversion requirements

Some of these laws include: Assembly Bill 341 for mandatory commercial recycling, Assembly Bill 939 requiring 50% diversion, and Senate Bill 1383 reducing short lived climate pollutants



Manage Closure plans with Certified Unified Program Agencies, CalRecycle, Water Quality Control Board and Local Enforcement Agent

Note that work continues on all closed Landfills, including both those that continue as transfer stations and those that are completely closed





A few Public Works Successes in Fiscal 2022/2023

- Completed the Long Valley Streets Project
- Obtained the Grant for Saddlebag Lake Project
- Road and Facilities Kept working through a Historic Winter
- Sustainable Recreation, Roads and Engineering worked together on the small Wild Willy's project to improve safety on Benton Crossing Road
- Closed Benton Crossing Landfill
- Increased operations at Pumice Landfill
- Hazmat Removal for the Mono County Jail Project

Some Fiscal Year 2023/2024 Public Works goals

- Mono County Jail Project Complete site preparation – Bid Construction Project – Begin Construction
- Complete Highway Safety Improvement Projects – in particular guardrails on Benton Crossing Road
- Complete environmental and Start Drainage improvements on Eastside Lane
- Complete Banner Project
- Complete Courthouse Painting
- Park improvements Walker, Bridgeport and Lee Vining (Prop 68)

# Challenges to Public Works

- Increasing Construction Costs
- Supply Chain Issues
- Location Mono County is remote to many contractors and resources, so costs can be higher, and competition limited
- Weather Mono County experiences extreme weather that limits the construction season
- Soil saturation. With numerous projects planned in the Bridgeport area, this year's soils saturation could cause delays. All areas of the county with storm damage also have saturated soils that must be stabilized to reach permanent solutions
- This year's winter season has delayed a lot of our normal operations.
