- **3. Public Comment:** Members of the public have the opportunity to address the Council on items of interest within the jurisdiction of the Council. **No Public Comment.**
- **4. Strategies TA:** Barbara DeGraaf gave a quick presentation about the new Strategies Technical Assistance (TA) program with Office of Child Abuse Prevention and the Child Abuse Prevention Center. Barbara explained that Strategies TA would be able to support the Mono County Child Abuse Prevention Council with either developing a County wide child abuse prevention plan and or with timed specific technical support. (*Informational*)

- 5. Approval of September 2, 2020 Minutes: Michelle Raust made a motion to approve the September 2, 2020 Meeting Minutes. Susi Bains seconded. All in favor. No abstentions. No further discussion. Motion passed. (Action)
- 6. Innovative Partnership Grant: Molly *DesBaillets* made a motion to approve the CAPC Coordinator to apply for additional CAPC funds from the Sierra-Sacramento Innovative Partnership Grant, up to \$692.00 to potentially purchase dual language CAP Month lawn signs and CAPC car magnets. Kelly Conboy second. All in favor. No abstentions. No further discussion. Motion passed. *(Action)*
- 7. **CAPC Flyer:** CAPC members reviewed and considered adopting the Mono County CAPC Flyer for future distribution. Michelle Raust had some recommendations and will email them to Courtney Powell. Sal *Montanez asked for the phone number and language be update to the Behavioral Health services.* Susi Bains made a motion to approve the Mono County CAPC Flyer with the pending changes. Molly *DesBaillets* second. All in favor. No abstentions. No further discussion. Motion passed. *(Action)*
- 8. Foster Youth Services Updates: Courtney Powell the CAPC Coordinator and Foster Youth Services

  Coordaining Program Coordinator shared that the Foster Youth Services Needs Assessment went out to

  21 people and currently ten have responded. The 2021-2024 RFA for the FYSCP Program has been

  released and due in May of 2021. Lastly, Courtney shared about an upcoming Strengthening Families

  Protective Factors Training of trainers will take place January 26th-28th all day and is open to 11 people
  that can support foster youth in Mono County. (*Informational*)
- 9. CAP Month planning: The Mono CAPC members discussed continuing what took place last year for a socially distant and virtual Child Abuse Prevention (CAP) Month activities in April. Activities that were virtual last year were as follows; wear blue day, pass the pinwheel, Children's Memorial Flag raising ceremony and a social emotional story time with Mono County Libraries. Some additional ideas were to work with the library to distribute pinwheel making kits. (Informational)
- **10.CAPC Program and Member Updates:** CAPC members and staff have the option to share information related to the mission of the CAPC. *(Informational)*

   Assembly Bill (AB) 2083 around Systems of Care MOU among serving agencies such as Office of

- Matthew O'Connor, Wild Iris: They are still functioning and providing support to those affected by domestic violence. CASA is doing well and they just completed another training of onboarding new volunteers. They will also be launching a CASA specific website. They will continue to operate remotely. They are looking to hire a new office manager.
