Project will restore areas impacted by illegal dispersed camping activities (loss of vegetation, litter, illegal fire rings) and install regulatory/restoration signage in prior-disturbed areas by use of hand-tools. This project will improve sustainable recreation/tourism offerings and conserve/restore natural resources that have been negatively impacted by illegal dispersed camping activities. Beneficiaries to the project include native flora and fauna, residents/visitors to Mono County, and small/large scale fire prevention for the region.
