Mono County Community Development Department

June Lake CAC – At the Sept. 6 meeting conducted by **Wendy Sugimura**, attendees considered a recommended update on the June Lake Area Plan, with a focus on short-term rental policies. The proposed policies represented the synthesis of over 40 hours of community workshops and meetings (not including staff preparation time and data analysis), research of best practices, and review of regulations in a few other jurisdictions. At the next meeting on October 4, the CAC plans to thoroughly review the information, mix and match policy options to form an update they hope to support, and take action to recommend a policy update to the Planning Commission. Special thanks to staff who attended to provide support and subject matter expertise, including **Scott Burns** (planning issues), **Nick Criss** (code enforcement issues), **Sheriff Ingrid Braun** (law enforcement response), and **Stacey Simon** and **Christy Milovich** (legal issues).



Active Transportation Program (ATP) Grant Funding: Bridgeport Main Street – The California Transportation Commission (CTC) staff recommendations for the 2017 ATP grant awards has been released, and Bridgeport Main Street made the cut! A reflection of the outstanding collaboration between the community, Caltrans, and Mono County, the \$434,000 project includes a hardscaped curb extension at the School Street crosswalk across US 395, and temporary (removable) curb extensions/pedestrian refuges at the Sinclair Street and Jolly Kone crosswalks. In response to community concerns about aesthetics, flower boxes may be planted and maintained by the community within the temporary features. Special thanks to **Garrett Higerd** (Public Works), **Terry Erlwein** (Caltrans), the **Bridgeport RPAC**, and **Sheriff Braun** for helping make this grant application successful.

California State Association of Counties (CSAC) Award: Thermal Biomass Project – CSAC has just announced that the Bridgeport Thermal Biomass Boiler Project received a *Merit Award in Agriculture, Environment & Natural Resources*. A record number of 288 applications were received for five award categories, and Mono County ranked in the top three for our category to receive this award. A true multi-departmental, collaborative effort, a long list of persons are to be congratulated, including **Joe Blanchard, Wendy Sugimura, Public Works staff** (Dave Campbell, Jason Davenport, Eric Eilts, Claude Fiddler, Jesse Hale, John Hauter, Tony Iniguez, Tom Music, Don Nunn, Elliot Ross, Paul Roten, and Bill Van Kampen), **Tony Dublino** and solid waste staff, and **Megan Mahaffey**. A number of external collaborators deserve recognition as well, in particular the Eastside Biomass Project Team, Great Basin Unified Air Pollution Control District, TSS Consultants, and the **Sierra Nevada Conservancy**, who provided grant funds for the project.



Bi-State Sage-Grouse Website – At the Aug. 29 Bi-State Executive Oversight Committee (EOC) meeting, **Jake Suppa** rolled out the new website for the acclaimed multi-jurisdictional Bi-State Sage-Grouse conservation effort. Intended to assist with “telling our story,” public communication, and conservation collaboration, Mono County took the lead to establish the website for the entire habitat area in both California and Nevada. Special thanks to **Wendy Sugimura**, and **the Bureau of Land Management, Bishop Field Office**, who helped fund and complete the project, as well as other conservation partners. It's Never Too Late To Quit Smoking

Good retirement benefits are on the mind of all employees, including County employees. According to CalPers figures, in 1994, a healthy 55 year old man was expected to live another 25.5 years. Now, he has another 29.5 years. His healthy 55 year old female colleague was expected to live another 29.8 years in 1994, now is expected to live 31.9 years.

The smoking history of 160,000 participants older than 70 who were part of the [NIH-AARP Diet and Health Study](#) were followed from 2004 or 2005 until the end of 2011 to see who had died. During the follow-up period, 12 % of participants who never smoked died, compared to 33% of current smokers. The earlier people quit the better, but there was still a benefit even for late quitters. Of those who quit in their 30s, 16% died. In their 40s: 20%. In their 50s: 24%. And in their 60s: 28%. Of those who started when they were younger than 15, 38% died, compared to 23% of those who started when they were 30 or older. It is recommended that long term smokers use a program (the ALA has its [own](#), as does the [American Cancer Society](#) and [California Smokers' Helpline](#) in conjunction with pharmaceutical help, such as nicotine replacement products or prescription medications (such as Chantix or Zyban). Your odds of success are greater if you use both. Bottom line: if you want to enjoy your retirement benefits, with good quality of life, for as long as possible, quit smoking.

Children on Board

According to Safe Kids Worldwide, child safety seats, when used correctly, can reduce the risk of death in a car crash by 71%. Follow these 6 tips to ensure your child's safety:



- 1 Always use a car seat for your child, even if you are just going down the road.
- 2 Make sure the safety seat is appropriate for your child's age and weight.
- 3 Make sure the seat is installed correctly. Safe Kids Worldwide offers a car seat checklist at [safekids.org/checklist/car-seat-checklist-parents-pdf](https://www.safekids.org/checklist/car-seat-checklist-parents-pdf).
- 4 Take your vehicle and car seat to a local car seat inspection event so a certified technician can help you install it properly. Check with your local fire or police station for an event near you.
- 5 Do not buy a used car seat unless you're certain it hasn't been in a crash. This means buying it from someone you know and trust, not from a secondhand store or at a garage sale.
- 6 Check the Consumer Product Safety Commission website at www.cpsc.gov for information on product recalls and any other safety-related issues that have been reported.

Deferred Action for Childhood Arrivals (DACA) program



As anticipated, the Trump Administration announced that it is rescinding the Deferred Action for Childhood Arrivals (DACA) program created by an Executive Order issued by President Obama. This rescission becomes effective March 5, 2018. This ostensibly provides Congress with a six-month window to pass legislation authorizing the DACA program, or something akin to it, to continue.

WHAT THIS MEANS FOR MEDI-CAL: Our state has the majority of DACA participants, with about 223,000 approved – 25% of the nationwide number. For purposes of county social services, we work most often with DACA recipients through the Medi-Cal program, as they are eligible for full-scope Medi-Cal benefits under the PRUCOL category. The California Welfare Director’s Association confirmed that from DHCS’ perspective, **nothing has changed about DACA participant eligibility for Medi-Cal**. All DACA participants continue to be eligible for full-scope Medi-Cal until further notice.

Wait List Opening - Housing Choice Voucher Program

Formerly known as the Section 8 Program, the Housing Choice Voucher (HCV) program enables low-income households to obtain housing in the private market with rental subsidy received through the HCV program. Typically, a household pays approximately 30%-40% of their monthly income towards their rent and the Housing Authority pays the difference to the landlord/property owner.




Tiffany Montanez joined the CPS, APS and IHSS division as the new Vocational Trainee. Tiffany was born and raised in Bakersfield, CA and moved to Mammoth Lakes almost 6 years ago where she and her husband raise their children and are actively engaged in the community.

In her first two weeks, Tiffany has already learned the process for receiving and documenting incoming reports of suspected child abuse and adult abuse - one of the most critical roles in the CPS/APS division.

Tiffany will be responsible for gathering key information from reporters to ensure that Social Workers have enough information to begin an investigation. She will

utilize State-mandated tools and follow protocol to determine initial safety threats for children, elders and developmentally delayed adults.

The Vocational Trainee supports all functions of child welfare and adult services, oversees office organization, and has direct contact with clients to assist them in accessing services towards bettering their lives. This role requires excellent communication skills and the ability to connect with people from all walks of life.

When asked why she applied for this role, Tiffany shared, "I want to grow more as a person and do something that has purpose and meaning in my life." Having grown up in a family with many struggles, Tiffany has an inherent understanding of the clients who come into contact with Social Services: "I want to be able to use my life experiences to hopefully help even just one mother and child someday. It would make everything I went through as a child/young adult worthwhile."

Like her husband, Sal, an employee of Mono County Behavioral Health, Tiffany shares the vision of "being a part of and doing something that is positive in our community." Tiffany is also motivated to be a role-model for her children and show them that "no matter what life throws at you, if you work hard and do not give up you can make your dreams come true and accomplish so much in life if you don't give up."

Department of Health Care Services Deferred Action for Childhood Arrivals (DACA) Rescission Frequently Asked Questions

1. Are DACA(s) eligible for Medi-Cal?

Yes. Under existing Medi-Cal policy, individuals with DACA status will continue to be eligible for state-funded, full scope Medi-Cal if they otherwise meet all other program eligibility requirements. DACA is one option used under the broader “deferred action status” immigration categories; DACA is not a specific Medicaid eligibility category. Individuals with DACA status are given Medi-Cal eligibility under a broader immigration category that includes a number of categories of non-citizens who are eligible for full scope Medi-Cal coverage under existing state law and California Medicaid policy. In California, this broader immigration category is known as Permanently Residing in the U.S. Under Color of Law (PRUCOL) and within this category, there are 16 different subcategories. Therefore, individuals with DACA status will not have their health coverage impacted unless they have other changes in their eligibility status (e.g., increase in income, no longer residing in California, etc.)

2. How does the rescission of DACA at the federal level impact Medi-Cal eligibility for existing DACA(s) in California?

There will be no changes to the Medi-Cal coverage for DACA recipients (adults or children) in California. Under existing Medi-Cal policy, individuals in a deferred action status category (or any other PRUCOL category) continue to be eligible for state-funded, full scope Medi-Cal if they otherwise meet all other Medi-Cal program eligibility requirements.

3. Does the rescission of DACA impact the eligibility processes at local county social services agencies?

No, there are no changes to the current business processes of county social services agencies in conferring Medi-Cal eligibility for individuals. Counties shall continue to apply existing Medi-Cal policy in determining Medi-Cal eligibility for immigrants with DACA status.

4. Is there anything I need to do regarding my Medi-Cal eligibility given this change?

No, there is nothing you need to do.

5. Will my Medi-Cal services be impacted by this change?

No, your Medi-Cal services and coverage are not impacted by this change.

6. Will my information as a DACA recipient be reported to the federal government?

The department is required under federal law to verify citizenship or immigration status for almost all individuals who apply for Medi-Cal coverage and to report data including demographic information and immigration status, to the federal government. The verification processes and data reporting are done solely for the purposes of administering the Medi-Cal program and are not reported for immigration enforcement purposes unless you are found to have committed a crime, such as fraud.

❖ Make sure everyone in your family knows what to do in all emergencies.




- Learn about the major types of disasters that could happen in your area.

- Mono County utilizes the **CodeRed Emergency Alert System** when a critical incident or emergency situation takes place within the county. This system can be used to notify the entire county or specific areas within the county of important information.

❖ Get a NOAA Weather Emergency Alert Radio

- Every home should have a battery operated emergency alert radio for severe weather reports and other emergencies.
- A weather radio will wake you up if an emergency warning is issued.



❖ Make sure everyone in your household can communicate in a disaster.

- Identify someone (or more than one person) that can be contacted for help in an emergency. Have more than one way to get in touch with them. Keep everyone's contact information with you.
