**Animal Control begins return to normal staff levels** - Animal Control is very pleased that a new Officer will be starting in the next week. Once the new officer is trained, state mandated service levels will be easier to attain.

Summer time can be a high animal traffic time and the animal control staff must address any reports of dogs running about without proper id. Under Food and Agriculture Code 31101, any dog found running at large without proper identification as required per Section 30951 may be seized and impounded. In addition, under the Health and Safety code 121575 and as Mono County ordinance 9.12.060 and 9.20.010, Animal Control staff is required to monitor rabies vaccination which is done through the licensing program.

**More Yellow Legged Frog Meetings announced** – From Robert Moler: The U.S. Fish and Wildlife Service has updated the public engagement schedule regarding the proposals to list and designate critical habitat for the Sierra Nevada yellow-legged frog, the northern distinct population segment of the mountain yellow-legged frog, and the Yosemite toad.

The Service will attend two community forums hosted by Congressman LaMalfa on the proposals. Both forums are scheduled for **Wednesday, September 4**. The Service will be available to address questions and concerns at these events.

The Service will also hold two public meetings and a public hearing regarding these proposals before the end of 2013. Their plan is to hold public meetings in two California counties where the Service is proposing to designate critical habitat for these species. They are going to hold these meetings after the draft economic analysis for the critical habitat proposal is available to the public that is expected in fall 2013. Written comments will be accepted at these meetings. **The Service plans to hold the public hearing in Sacramento after the draft economic analysis is available. Written and verbal testimony will be accepted at the public hearing.** 

When they are set, USFW will announce the dates and times of the meetings, the hearing, and other updates to this issue. Although the Service cannot hold a meeting in every county identified in these proposals, they will try to attend other events such as regularly scheduled meetings of the County Board of Supervisors.

The Service is working with the U.S. Forest Service, the National Park Service, and the California Department of Fish and Wildlife in managing the public lands for the conservation of these species. These agencies are working together to coordinate outreach for these proposals.

Written testimony from the public regarding these proposals can be submitted during any open comment period. **The current open comment period for these proposals closes November 18, 2013.** Another comment period will open when the draft economic analysis is available, expected fall 2013.

#### **Information Technology**

**D395 Update** - Mike Ort notified IT clearance was granted from the Inyo National Forest to begin work on the nine (9) mile segment behind Crowley Lake Dam. Praxis plans to start construction next week, and will work in the area outside of the archeologically sensitive zone (which accounts for about a mile of the total area) from either end.

Praxis is coordinating with Mono County IT and Public Works on the effort, and seeking to close Round Mountain Road during the construction period so as to not impact the area outside of the travelled roadway. Praxis anticipates construction will take about a month, and hope to have connectivity between Barstow and Carson City by early October.

**Mono County submits comment to California Public Utilities Commission (CPUC) for D395 additional funding** - Mono County submitted three comment letters to the CPUC on August 21<sup>st</sup> in support of Resolution T-17408 which would grant Praxis another \$10m to complete the project. There were four letters submitted in total on the resolution, all in support. The Resolution will be heard by the Commission on September 5<sup>th</sup>, and if it passes, Praxis intends to go full steam with the final parts of the construction effort to get work done before the snow falls.
