Community Development

Local Transportation Commission – At its Monday meeting the LTC approved a midyear budget adjustment to the current Overall Work Program, received its annual audit and considered the 2014-15 OWP provided by Megan Mahaffey. Gerry Le Francois presented an update of the recent favorable review of Mono County's \$15 million proposed transportation improvement program by the California Transportation Commission.

February 14, 2014[BOARD OF SUPERVISORS UPDATE]

The LTC also reviewed its Yosemite policy, including Caltrans' wintertime closures of dry roads. The commission urged Caltrans to consider reopening Tioga Road up to the Yosemite gate for recreation during low-snow time. District 9 Director Tom Hallenbeck highlighted that Caltrans policy is based on safety and resource considerations that include rockfall on unstable slopes created by freeze-thaw conditions and no snow poles for delineation during snowfall. He reported that Caltrans intends to reopen Hwy 120E when crews complete maintenance, which would be welcomed by Tri-Valley residents. The Eastern Sierra Transit Authority reported ordering four Sprinter-type vehicles for improved efficiency on selected routes.

Mono Basin RPAC – With more than 30 people in attendance at its Wednesday meeting, County Counsel Marshall Rudolph presented an in-depth overview of Conway Ranch opportunities under current conservation easement efforts with the Eastern Sierra Land Trust. Supervisor Alpers also provided an update on Board matters, with a focus on the midyear budget review.

Planning Commission – At its Thursday meeting, the Planning Commission conducted a workshop on the draft Resource Efficiency Plan with Wendy Sugimura providing significant feedback for refining policies. Brent Calloway also led a workshop on a number of development standard adjustments under consideration as a part of the General Plan update. The commission also reviewed changes to bylaws with Commission Secretary C.D. Ritter and Assistant County Counsel Stacey Simon.

Reconstruction of Rock Creek Road Will Improve Access – Press release from Yosemite Gateway Partnership – "Bishop, Calif., February 12, 2014 - Major reconstruction on the Rock Creek Road is planned for the duration of the 2014 and 2015 seasons.

The Federal Highway Administration (FHWA) has contracted and will oversee the project that will improve the road, widen it, and provide a bicycle lane.

The Rock Creek Road provides access to wilderness trailheads for the Little Lakes Valley, Mono Pass, and others. The area is noted for its exceptional scenery. Several campgrounds and resorts with cabins along the road are part of the recreational attraction as is fishing and horseback riding. The road itself is used by cyclists because of its challenge and its beauty.

"This project addresses a desire of the visiting public to have safer access up to the popular recreation areas along Rock Creek," said District Ranger Margaret Wood. "We request your patience in the short-term during this project that will dramatically improve the experience in the long-term."

Weather dependent, the work is anticipated to start the beginning of May. This year, re-building of utilities and culverts is planned. Additionally, the reconstruction will begin along the upper part of the Rock Creek Road.

While the road will remain open to traffic throughout the project, visitors may experience delays of up to 30 minutes. Additionally, at certain times, the road may need to be closed for longer periods of time, Monday through Friday. These closures will be planned approximately two weeks in advance so that recreationalists can plan their visit. Parking areas may be limited at times while construction work is completed.

Construction will be suspended for Memorial Day weekend, the Independence Day holiday, and Labor Day weekend in order to minimize delays.

Economic Development

- Visit California Outlook Forum. Staff attended Visit California's annual tourism conference last week in Los Angeles. Both domestic and international visitation to California as a whole is on the rise here is some research that was shared at the conference:
 - **1.** Tourism generated \$106.4 billion in spending in California in 2012, up 4.5 percent from 2011.
 - 2. During 2012, travel spending in California directly supported 917,000 jobs, up 2.8 percent from 2011, while earnings increased 4.9 percent to \$32.3 billion.
 - 3. Travel spending in 2012 generated \$6.6 billion in state and local tax revenue. Domestically, California had the largest market share of domestic travel among all 50 states with a mark of 10.49 percent in 2012, with primary out-of-state domestic markets being Arizona, Nevada, Texas, Washington, New York and Oregon.
 - 4. International travel continues to be the main focus of Visit California's marketing effort. In 2012, 6.4 million overseas travelers visited California and spent approximately \$12.9 billion in the state. In 2014, international visitation to California is forecasted to increase 4.9 percent, and spending is expected to increase 8.1 percent. California's top overseas visitor markets in 2012 were: China (717,000), U.K. (675,000), Japan (590,000), Australia (546,000), Germany (420,000), S. Korea (409,000), France (368,000), Scandinavia (211,000) and India (208,000).
 - Our country's immediate neighbors continue to show increased visitation - nearly 7 million visitors from Mexico to California in 2012 up 1.9 percent
 from 2011 and 1.54 million visitors from Canada in 2012, a 4.5 percent
 increase from 2011.

Trade Shows. Both the Bay Area Travel Show and the Los Angeles Travel Show were wellattended. Mono County obtained over 600 leads at the Bay Area and almost 1000 at the Los Angeles show, and approximately 2000 Mono County calendars and 1700 Visitor Guides were distributed at each show. While many attendees were familiar with Mono County, staff observed that there seemed to be a significantly larger number of folks who had never been to Mono County or who had not visited for many years – so 1:1 opportunities to educate and encourage potential travel were plentiful. March is extremely busy for trade shows with Mono County exhibiting at two Fred Hall Fishing shows (Long Beach and Del Mar) and the San Diego

Travel show. In addition, Alicia Vennos will be representing the High Sierra Visitors Council (HSVC) at the Visit California New York Media show in March, (funded entirely by HSVC).

- June Lake Winter Festival cancelled. Disappointed organizers of the June Lake Winter Festival and Snowmobile Rally have unfortunately had to cancel the event this year, scheduled for Feb. 28 Mar. 1, due to lack of snow in the valley.

Film Commission. Interest in filming has picked up this month with a number of scouts seeking frozen lakes and snowy mountain landscapes for commercials, as well as a major television network searching for 35 acres of privately-owned remote land for a 6-month reality show, August through November 2014. Staff is sourcing potential properties – any ideas, please contact Jeff or Alicia. Due to California's significant loss of film productions to other states (and countries) with more aggressive tax credit incentives, the California Film and Television Production Alliance has organized a series of meetings in Sacramento, beginning February 19, to educate legislators on the vital need for an enhanced version of the California Film & Television Tax Credit Program.

- **USFS Management Plan Revisions.** Staff attended the U.S. Forest Service's public workshop in Bishop on Jan. 30 to review the recently released preliminary *Need to Change* which will drive how the Forest Service revises its management plans. Community and Economic Development department's comments were jointly submitted by the deadline on the following day.
- EIA Analysis. Staff is also working with Community Development and County Counsel to identify areas of concern in the Frogs/Toads Economic Impact Analysis (EIA), in addition to participating in a lengthy conference call with the US Fish & Wildlife Service consulting firm currently working on the Sage Grouse Economic Impact Analysis.
- CDBG Grant Update. A Request for Proposal was sent out last week for consultant services to implement a Community Development Block Grant (CDBG) for an Economic Development Planning and Technical Assistance grant. The consultant will develop a business plan which addresses four required topics: Marketing, Underwriting, Loan Management and Program Administration. The business plan will serve the purpose of creating or expanding capacity for Bridgeport Development Corporation and/or Mono County to function as local business developer and lender under the CDBG microenterprise program and/or the business assistance loan program. Rim Rife - USDA Emergency Loans available to Local Ranchers and Farmers - On December 13, 2013, President Obama declared the Rim Fire a Federal Major Disaster. Pursuant to the declaration, the United States Department of Agriculture (USDA) is offering an emergency loan program to assist local farmers and ranchers who conduct family sized farming operations and had physical or production losses caused by the fire that occurred from August 17 – October 24, 2013.

California Drought - \$20 million available for agriculture conservation and enhancement - Feb. 4, 2014 – Agriculture Secretary Tom Vilsack announced USDA will make \$20 million available for agricultural water conservation efforts throughout California to combat the effects of drought. Interested landowners and managers have until March 3, 2014 to apply for available funds. Funds will be divided between two specific funding pools: cropland and grazing lands. Cropland with a reduced water allocation of at least 85 percent will receive the highest priority. In order to be considered eligible for Environmental Quality Incentives Program (EQIP), the applicant must have a vested interest in agricultural production and meet other program eligibility requirements.

The IT department conducted a training for staff at the Town

hard at work designing the technology rules to support the policy requirements. The policy is an important part of minimizing discovery times for Public Record Act requests, and ensuring appropriate use of technology systems such as email. IT is currently working with County Counsel to establish a similar policy for the County.

protect the infants as parents and close contacts are then less likely to spread the disease (this is known as cocooning).
