Letter to the Editor

In November of 1863, President Abraham Lincoln delivered *The*Gettysburg Address in which he said that "government of the people,
by the people, for the people, shall not perish from the earth". This coming June 3<sup>rd</sup> is Election Day, a
day dedicated to every citizen to represent their opinion by voting. Without voting, citizens would not
have the right, power, or liberty of choosing, or the ability to hold elected representatives accountable.

Voting is fundamental to preserving a strong democracy, and it is important to remember that outcomes depend on those who participate. It may please you to know that in the last General Election, November 6, 2012, out of the 58 counties in California, Mono County ranked 2<sup>nd</sup> in voter participation with a turnout of 87.30%, only .07% behind the number one county. This is something the voting public of Mono County can truly be proud of. But you can't vote unless you are registered. If you are uncertain about your registration or if you need to update your information, I encourage you to contact my office before May 19<sup>th</sup>, which is the last to register to vote in the June 3<sup>rd</sup> election.

The Mono County Racial and Ethnic Disparity Team applied for the Center for Juvenile Justice Reform: Reducing Racial and Ethnic Disparities in Juvenile Justice Certificate Program at Georgetown University, Washington D.C. The team was recently notified that the team, along with several others throughout the United States, had been selected from hundreds of applicants to participate in this prestigious program.

The RED Juvenile Justice Certificate Program is an intensive training design to support local jurisdictions in their efforts to reduce racial and ethnic disparities in their respective juvenile justice systems. The program is operated jointly by the Georgetown Center for Juvenile Justice Reform (CJJR) and the Center for Children's Law and Policy (CCLP).

The Team will have to complete research and prepare reports prior to attending and upon returning, participate in the Capstone Project for the following 12 month-period. One a team has completed their curriculum and Capstone project, they will become members of the Fellows Network which is comprised of CJJR alumni. The Fellows Network supports the development of current and future leaders working to improve treatment of youth in the juvenile justice system.

**EMS provides needed training to Tri-Valley** -- Mono County EMS recently visited the Tri-Valley, bringing needed First Responder training to EMT's and Emergency Medical Responders from Chalfant and White Mountain (Benton)



Fire Departments. The EMS Department is making an effort to reach more volunteers throughout the county, whom often have a difficult time finding continuing education credits necessary for recertification.

EMTs and First Responders require 24 hours of such credits, and a skills evaluation every two years. EMS has been in the process since January of bringing department personnel up to requirements to be

"CE Providers," thus enabling classes to be held at

all four stations on a rotating basis.



EMS has also identified a training site with the American Heart Association, and will have a dozen qualified CPR/AED instructors by the end of June. The departments goal for the remainder of this year and next is to bring classes to every county employee, and to establish a county wide AED program.

The following was evident from the survey results:

- Some community members have a difficult time obtaining dental care.
- Residents believe that overweight and obesity is a local concern and should be addressed.
- Some local infants are put in unsafe sleep environments, increasing the risk of Sudden Infant Death Syndrome (SIDS).

Inyo and Mono County Tobacco Control Programs collaborated in a first Choo Choo Swap Meet adult cessation effort - After years of observing evidence of chronic disease and tobacco use among attendees, it was decided to try a quit tobacco booth at the Swap Meet. Nine quit smoking or chew packets were given

away and 13 quit smoking stories were collected for use in future educational media.

A most unusual case was a man who experienced "counter-conditioning" at Schick Shadel Hospital in Seattle. He stated: "The first week, electrodes placed put on the forearm and you get an electric shock with each drag. In the second week, you get to smoke, but have to inhale when they tell you. So it goes, '1-2-3 drag; 1-2-3 drag.' You get sick and dizzy. After I quit, my son told people, "My Daddy isn't going to die because he quit smoking." When in the military, they put 4 Marlboros in our C-rations. I had many sick calls for chronic bronchitis, but that stopped when I quit smoking. It was the best thing I ever did." While "counter-conditioning" is not a recommended by the Health Dept., calling the California Smokers' Helpline is: 800-NO-BUTTS.

# **Sheriff's Office**

Bear Activity throughout the community of Crowley Lake
Spring is making its way into the Eastern Sierra and the
communities of Mono County. Springtime means local roads are
opening, fishing season has begun, wildflowers are in bloom, and
local wildlife are starting to come out of hibernation looking for
food.

This is the mountains and bears do share our space. There have

been a few reports in the community of Crowley Lake of a local bear snacking on bird feeders and bird seed. Where many of us try to help feed local wildlife, like the birds, please remember this also attracts other wildlife, such as bears. Due to the current drought conditions, it is anticipated that bears may be forced to seek out food other than their native diet. Please remember some simple tips to lessen the likelihood of a bear encounter: to avoid vehicle break-ins, do not leave food, wrappers, ice chests, lunch boxes, etc. in your vehicle; do not leave outdoor trash cans open, unattended and unsecured; use proper bear proof food storage containers; do not leave out any type of food including pet food and bird seed; make sure all BBQ's and outdoor cooking areas are kept clean to prevent problems with bears; and, if you accidentally come "face to face" with a bear, slowly step back and make as much noise as possible to alert the bear of your presence. Please do not take matters into your own hands. These simple tips are for your safety and the safety of our local bears.

If these simple tips do not work, and your safety is still at risk, please do not hesitate to call the Mono County Sheriff's Office at (760) 932-7549 ext. 7 for non-emergencies, or 911 for emergencies, or the California Department of Fish and Wildlife. Please be safe and cognizant of wildlife in all communities throughout Mono County!

Social Services Staff continues to help community access health while facing statewide backlogs - There is large backlog of Medi-Cal applications estimated at 900,000 people statewide, according to the latest figures provided by the Department of Health Care Services.

The ongoing glitches and unresolved technical defects in the new state health care computer system, known as CalHEERS, means people are still awaiting final confirmation of their Medi-Cal coverage. In some cases, people have had their applications in "pending" status for several months, some as far back

as December. Locally, Mono County Social Services recognizes the anxiety this causes our clients, and are in daily conversations with our State partners to resolve the issues.

Despite many challenges over the last several months, our county Social Services staff successfully enrolled hundreds of people into Medi-Cal, and our staff have taken great pride in being part of making the Affordable Care Act become a reality in California. However, we cannot expeditiously move through the backlog of applications and finalize people's benefits until the defects and performance issues in the new state system are resolved.

Our dedicated Social Services staff is doing everything within their control to process applications and verifications so those who are eligible can get their Medi-Cal health care benefits turned on as quickly as possible.

#### Remember:

- If someone is in need of immediate care or emergency services, individuals should make sure our county eligibility workers are aware of those situations so workers can take immediate steps to get the individual health care benefits. Remember that, once approved, Medi-Cal coverage will be started back to the date of application. Individuals also could be eligible for up to three months of retroactive coverage prior to their application date.
- Medi-Cal enrollment unlike Covered California enrollment is year round. If you or someone you know believes you might be eligible for Medi-Cal, please visit or contact your county social service office to start the Medi-Cal application process.
- Keep in mind Medi-Cal eligibility has changed and expanded under the Affordable Care Act and those who previously were not eligible may find themselves eligible today.

Ensuring children, families and individuals who are eligible for health and human services in our communities receive needed assistance continues to be our central tenet. Enrolling people into Medi-Cal, CalFresh and CalWORKs is what we specialize in 365 days a year, and that is still the case under the Affordable Care Act. We remain steadfast in our commitment to serve our clients to the best of our ability.
