## **Community Development**

**Feds support Mono County effort to prevent Sage Grouse listing** - On Friday morning, major news outlets began reporting that the Obama administration has committed \$31 million to conservation efforts for the Bi-State sage grouse. This figure is precisely what we have requested to fully fund and implement the "Bi-State Action Plan" in an effort to prevent listing of the Bi-State Distinct Population Segment of the Greater Sage Grouse under the Endangered Species Act.

The appropriations are split between the Department of Agriculture (Forest Service and Natural Resource Conservation Service) and the Bureau of Land Management, and includes funds for the purchase of conservation easements as well as habitat improvement projects. Agriculture Secretary Tom Vilsack described the funding as a "ground-breaking commitment". While there are no guarantees that the species will not be listed, this is great news for all involved with species conservation, and most importantly, great news for the recovery and long term sustainability of our local Sage Grouse.

Serve Your Community by Becoming a Civil Grand Juror – The Mono County Courts sent out a request for applications for the Grand Jury. The application is attached to the Board Update. This is a great opportunity to serve the community. Please share with friends, family and consider participating!

What is a Civil Grand Jury?-a civil Grand Jury is made up entirely of community volunteers whose primary mission is to examine all local government agencies to determine if they are serving the residents of the county in a legal, economical and efficient manner. Grand jurors are appointed by the Presiding Judge of the Mono County Superior Court, Stan Eller.



What Does a Civil Grand Jury Do?- California law sets out certain legally required investigations to be done by the Grand Jury, however, the Grand Jury on its own initiative can investigate any local government agency it chooses. In addition, the Grand Jury can investigate local government agencies based on written concerns or written complaints made by members of the public. The Grand Jury has a year to do its investigations and then must submit a final Grand Jury report to the Presiding Judge that will be distributed to the public and to local government.

What is My Commitment if I Serve As a Grand Juror? - the Presiding Judge will appoint grand jurors to serve for one year from July 1<sup>st</sup> to June 30<sup>th</sup> of the next year. Grand jurors can expect at least one general meeting a month of the entire Grand Jury; time and place of the meetings to be determined by the Grand Jury members. In addition, once the Grand Jury starts investigating local government agencies, there will be committee meetings to do the investigative work. The amount of time spent on committee meetings and investigative work is determined by the Grand Jury members. Grand jurors are also asked to attend a two-day Grand Jury training to be held in Bishop on August 7<sup>th</sup> and August 8<sup>th</sup>. Grand jurors are volunteers, however, grand jurors are reimbursed for mileage to attend Grand Jury general meetings, committee meetings and training.

**Does the Grand Jury Receive Any Support or Assistance?-** The Grand Jury is appointed by the Presiding Judge of the Superior Court and has legal authority to support its investigative activities. The Grand Jury receives administrative and technical support from the CEO of the Superior Court. Legal advice is provided to the Grand Jury by Superior Court, the County District Attorney and County Counsel. **How do I apply?-** Before June 25<sup>th</sup>, you can apply by contacting Hector Gonzalez, CEO of the Superior Court by either phone (760-923-2330) or by mailing the flyer with your contact information provided

**BLM Bishop Field Office & Inyo National Forest Announce Fire Restrictions** - Effective Friday, June 27, the Bureau of Land Management(BLM) Bishop Field Office and the Inyo National Forest are implementing fire restrictions.

The restrictions are in effect on all BLM public lands managed by the Bishop Field Office and all Inyo National Forest lands.

"Ongoing drought conditions and well below average rain and snowfall this past winter have led to very dry conditions for this time of year," said Inyo National Forest Supervisor, Ed Armenta. "These conditions can create an active fire season here in the Eastern Sierra. We have experienced 15+ fires already and numerous Red Flag Warning days.

Beginning June 27, and until further notice, the following restrictions will be in effect:

• NO CAMPFIRES, briquette barbeques, or stove fires are allowed outside of designated developed recreation sites and specifically posted campsites or areas. A list of designated campgrounds and recreation sites is available at local Ranger Stations and Visitor Centers, and on the Inyo National Forest website, <a href="http://www.fs.usda.gov/Internet/FSE\_DOCUMENTS/stelprd3805273.pdf">http://www.fs.usda.gov/Internet/FSE\_DOCUMENTS/stelprd3805273.pdf</a>.

Persons with a valid California Campfire Permit (available free of charge at any Ranger Station or Visitor Center) are not exempt from the prohibitions but are allowed to use portable stoves or lanterns using gas, jellied petroleum, or pressurized liquid fuel.

• NO FIREWORKS. It is prohibited to possess or discharge any fireworks.

• NO SMOKING, except within an enclosed vehicle or building, a developed recreation site, or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable material.

- NO WELDING or operating an acetylene torch with open flames, except by permit.
- NO USE OF EXPLOSIVES, except by permit.

Inyo National Forest wilderness areas which are exempt from this order are Hoover, John Muir, Ansel Adams, Boundary Peak, White Mountains, Golden Trout, and South Sierra. Resorts, pack stations, recreation residences and other sites operated under special use permit from the U.S. Forest Service or BLM may be exempt from the special orders, as long as any fire activity is conducted in compliance with their permit. Special use permit holders should contact their permit administrator to make sure they are on the list of exempt sites, or check the information for special use permit exemptions on the Inyo National Forest Website, www.fs.usda.gov/inyo.

Steve Nelson, BLM Bishop Field Manager and Ed Armenta urge the public's cooperation in helping to prevent wildfires in this year of very high fire danger, and they remind both residents and visitors that fireworks, even "Safe and Sane" are not allowed at any time on public lands.
