- 1. The Assessor's Office has finished processing the 2014-2015 Annual Assessment Roll. The total roll value is \$5,369,971,677. This represents a 1.69% increase over the 2013-2014 roll, and is the first time since 2009-2010 that Mono County has had an increase over the previous year's roll.
- 2. Value notices for all properties in Mono County are now available to be viewed and printed online. Go to <u>http://monocounty.ca.gov/assessor/page/assessor-data-inquiry</u>, and enter either the property address or parcel number. You will be taken to a page that has some basic information about the property. At the top of the data is a link to view/print the notice. For people that do not have internet access, the Assessor's Office will still print and mail a copy to property owners if requested.


