Mono County Courts to close one day a month due to state budget cuts – Thank you to Hector Gonzalez for his heads up on Court closures. The following is from hector and the Press Release is attached to the Board Update as well.

"Beginning on October 31, 2014, the Mammoth Lakes Courthouse will be closed to the public every third Friday through the remainder of this fiscal year (13 days). The first Friday for closure of the Mammoth Lakes Courthouse will be October 31, 2014. The Courthouse will be closed, however, a judge with one clerk will be available to deal with arraignments, orders or documents needed on an emergency basis. We'll be working on a process for justice partners to contact the Court and have access to the courthouse for the aforementioned emergency needs on closure days. A drop box will also be available for use at the courthouse starting October 31, 2014. The every third Friday closures are necessary due to the deep cuts in the state funding allocated for the Superior Court of Mono County. Please see the attached public notice for the specific dates the court will be closed and more detail about emergency court services available on closure days.

Seven (7) New Shelter Volunteers!! - As part of our on-going efforts to be prepared in the event of an emergency shelter opening, Social Services recently facilitated a Shelter Fundamentals training

presented by the American Red Cross. Through this training and other outreach efforts, Social Serves was able to **recruit seven (7) new volunteer Shelter Managers** in the communities of Mammoth Lakes, June Lake, Crowley Lake, Chalfant, Bridgeport and Lee Vining. This enables us to establish a local resident in <u>all</u> of our communities to serve as a Shelter Manager. All of the managers have completed the Shelter Fundamentals course and many of them have previous experience with emergency services such as FEMA and CERT and some have past employment backgrounds with various fire departments.

Our new Manager in Chalfant recruited 10 new volunteers to assist with shelter operations. However, there is still a great need to recruit additional volunteers in all of our communities. If you or anyone you know may be interested in volunteering, please have them contact the Mono County Shelter Coordinator, Cathy Young at 760-924-1780. An online "Shelter Fundamentals" training is available to anyone that is interested. A recruitment flyer is attached to this newsletter. Please help spread the word!



Mono County Social Services has just finished a complete inventory of the eight

(8) emergency shelter trailers throughout the County with the assistance of each of the Shelter Managers. The Shelter Managers feel this was a great exercise and they are much more comfortable and prepared to open and operate a shelter. Along with completing the inventory, the Shelter Managers also designed a floor plan to expedite a shelter opening in a timely manner.
