**SUMMARY** - The State Water Resources Control Board (State Water Board) is exploring a range of options to enhance environmental benefits from grazing, protect beneficial uses of surface and groundwater, and address water quality impacts potentially related to livestock grazing in California. This Grazing Regulatory Action Project (GRAP) aims to facilitate efficiency and statewide consistency in developing and implementing strategies to meet these goals, while at the same time accounting for regional differences in hydrology, topography, climate and land use. The GRAP process will consider a wide range of alternatives to ensure that grazing has minimal negative impacts on water quality. A cornerstone of the GRAP will be thoughtful consideration of the costs of compliance to the regulated grazing community. The participation of interested stakeholders throughout the development of GRAP is necessary to its success. As an initial step, the Water Boards engaged stakeholder groups in Focus Listening Sessions (FLS) to solicit comments early in this process, before beginning to develop GRAP (No new regulatory approach has been developed.) The FLSs were the first of many opportunities for stakeholder participation. The purpose of the Regional Stakeholder Meetings is to share with stakeholders the comments from the FLSs and gather thoughts, suggestions or other feedback from the community on the FLSs comments and on GRAP.

The freezing temperatures are a stark reminder that pet care should be on everyone's mind.





# **Information Technology**

**Digital 395 sees two new applicants to enhance Mono County Internet Underserved communities** – Race Telecommunications, Inc. has submitted two grant requests to the California Public Utilities Commission totaling over \$12 million. If funded, these





projects will greatly enhance the connectivity of South Chalfant, Benton, Swall Meadows, Lee Vining, and Mono City, Walker and Bridgeport.

Then projects involve Fiber based Internet speeds will offer packages including 1Gbps. This project is called *Gigify Mono*. In addition, Race Communication has put in an application for the *Gigify North 395* which would, if funded, deploy a fiber-to-the-premises (FTTP) Last Mile network to serve 100% of the homes in a defined service area that includes Bridgeport and Walker, California. Fiber based Internet speeds will offer packages including 1Gbps (1000 Mbps) down and 1Gbps (1000 Mbps) up. The full applications with maps are included as attachments to the Board Update.

This could be the next level of needed investment for our residents who deserve equal access to Internet resources.

**Federal Court order strikes down FLSA regulations -** On Wednesday, December 31, 2014 the U.S. District Court for the District of Columbia issued an order earlier this week in favor of plaintiffs of the litigation over the FLSA regulations for personal care workers. The federal overtime pay requirements for home care workers was due to go into effect 1/1/15, and would have impacted our In-Home

Supportive Services (IHSS) program recipients and their providers. The litigation was filed by the National Association of Home Care & Hospice asserting that the U.S. Department of Labor (DOL) rule is in direct conflict with the Fair Labor Standards Act as passed by Congress in 1974.

The one-page court order concluded that the U.S. DOL's Third Party Employer Regulation is VACATED. The specific regulation cited in the order provides "[t]hird party employers of employees engaged in companionship services ... may not avail themselves of the minimum wage and overtime exemption" provided by the statute, and "[t]hird party employers of employees engaged in live-in domestic service employment ... may not avail themselves of the overtime exemption" provided by the statute.

U.S. District Judge Richard Leon says the rules conflict with federal law that has long exempted providers of in-home care for the elderly and disabled from complying with wage laws. The Memorandum Opinion (also attached) states, "Plaintiffs, on the other hand, contend that the exemption enjoyed by third-party employers over the past forty years is not an open question and the Department of Labor cannot, therefore, manipulate its definitional authority in such a way as to effectively rewrite the exemption out of the law. [Pls Mem. at 11-13.] I agree with the plaintiffs."

This means that:

• The IHSS program in California will **not** be implementing payments for overtime, travel time, or wait time for providers of services at this time, and

• The "hours cap" of 61 hours per week for each provider will **not** go into effect at this time. All authorized hours worked will be paid only at straight-time (the locally bargained hourly wage), and travel and wait time will not be paid. **This means providers will be paid the same way they were in 2014 until further notice.**

**5 Things to know about Marketplace Open Enrollment** - Open Enrollment is the period when you can sign up for or renew a health plan through Covered California, the Health Insurance Marketplace.

Here are 5 important things to know:

- 1. 2015 Open Enrollment lasts until February 15, 2015.
- If you don't enroll in a health plan by February 15, 2015, the only way you can get health insurance for 2015 *through the Marketplace* is if you qualify for a <u>Special Enrollment Period</u>. You may qualify if you have a qualifying life event such as marriage, birth or adoption of a child, or loss of other health coverage.
- 3. You can apply for **MediCal** at any time of year. If you qualify, you can enroll immediately. To find out, go online to <u>www.C4Yourself.com</u> or call 760/924-1770 to make an appointment with a Mono County Eligibility Worker. We are here to help!
- 4. You can preview 2015 health plans and estimated prices before you apply through the <u>Covered</u> <u>California Shop and Compare Tool</u>.
- 5. When you buy health coverage for your employees through the Small Business Health Options Program (SHOP) Marketplace, you <u>may qualify for a tax credit</u> worth up to 50% of your premium contributions.

**Covered California Referrals to Medi-Cal** - Some individuals who were previously receiving subsidized health care coverage under Covered California plans may no longer be eligible for those subsidies after December 31, due to changes in their incomes, and they will now qualify for health care coverage through Medi-Cal.

Known programming problems with CalHEERS and the tight timing have made this effort more challenging, but counties are working closely with the Department of Health Care Services to expedite enrollment for affected individuals and avoid gaps in coverage to the greatest extent possible. We understand that the state will take steps to ensure there is no gap in coverage by enrolling individuals into Medi-Cal this month if their cases are still pending.

Notices from Covered California will be going out to those consumers affected by this change to explain their options and what actions they should take in the coming weeks. Once these individuals are enrolled into Medi-Cal, they will receive information from the Medi-Cal program confirming their eligibility.

We recognize that Covered California's consumers have not been given much time to make the transition – nor have counties. We will do everything in our control to get people enrolled into their new Medi-Cal coverage as soon as possible.

Keep in mind this is relevant only to a group of Covered California consumers who are renewing coverage *and* whose income level caused them to lose eligibility for subsidized coverage in Covered California and instead appear eligible for Medi-Cal.
