Community Development

Antelope Valley RPAC – At Thursday's meeting RPAC member discussed a proposed communications upgrade project at Mountain Warfare Training Center with Doug Power of the MWTC and Jeff Ulrich of USFS and requested an extension of the environmental comment period. Supervisor Fesko provided an update on BOS activities and commended the RPAC and Vianey White for their continued efforts on the Mountain Gate project. OHV use, including potential combined use on County roadways, was also discussed, and Gerry Le Francois provided an update on the Main Street design process.

Thermal biomass grant – This week Wendy Sugimura received notification from the Sierra Nevada Conservancy that the Bridgeport road shop thermal biomass application was funded in the amount of \$215,000. Big thanks to Wendy and other key members of Mono's Energy Task Force, including Tony Dublino, Joe Blanchard, Megan Mahaffey, and Jason Davenport, for assembling a successful application.

Transient Rental Overlay District (TROD) – On Dec. 2 the Mono Supervisors approved two TROD applications at June Lake presented by Courtney Weiche, with enforcement clarification by Nick Criss. TRODs allow overnight rental of single-family homes in residential neighborhoods.

Housing – At Tuesday's meeting the BOS reviewed housing statistics with Brent Calloway and initiated continued suspension of housing mitigation requirements. The Board also considered a request for proposals presented by Megan Mahaffey to administer a first-time homebuyer loan program. The program is funded through a recently acquired federal grant of \$700,000.

Certifiable – Congratulations to Code Enforcement Officer Nick Criss on his most-recent certification. The California Association of Code Enforcement Officers has conveyed the highest-available rating to Nick as a certified code enforcement officer. A shout-out to Mono County's best (and only) compliance officer!

National Association of Counties successfully helps support counties receive owed funds - PILT Funding in the FY15 National Defense Authorization Act — From the NACo Press announcement some good news from Congress -- Although there are many moving parts as the 113th Congress winds down, we wanted to provide you with an update on the latest Payments in Lieu of Taxes (PILT) and Secure Rural Schools and Community Self Determination Act (SRS) activity on Capitol Hill.

Late in the evening of December 2, the House and Senate Armed Services Committees announced that they had reached a compromise agreement on the National Defense Authorization Act (NDAA) for fiscal year 2015 (FY15). Historically, Congress has passed an annual National Defense Authorization Act to set U.S. defense policy and military spending levels for the year ahead. In addition to defense policy, the *FY15 NDAA includes \$70 million in appropriations for the PILT program* and a package of natural resources related legislation addressing issues such as energy and mineral production, land use issues, and land conveyances. (More information on the NDAA provided by the House Armed Services Committee is available here. A summary of the federal lands provisions provided by the House Natural Resources Committee is available here.)

NACo has been in touch with staff for House and Senate Leadership and with the committees with jurisdiction over PILT funding. They have told us that the \$70 million is the result of savings created by

the NDAA's federal lands package. The decision was made to redirect the savings to support the PILT program. The \$70 million within NDAA should be understood as a down-payment and as intended to provide some budgetary relief for the committees of jurisdiction as Congress continues to work to fund PILT, with appropriate offsets. The \$70 million will help ensure PILT is fully paid for. It has been stressed that the PILT funds made available in NDAA are not intended to be a final funding level for FY15 and that PILT will be further addressed in future legislation.

Holiday season brings SPAM, Scams, and Online security threats - With the holiday season upon us, it is important that everyone be reminded of the importance of the precautions necessary to protect your online privacy and avoid scams and other cyber security threats.

During this time of year, a lot of us shop online, receive confirmation messages, as well as general emails soliciting us to purchase things. Regardless of whether you are expecting a message from a company or are looking at one that is a general solicitation, it is important to follow some Basic Rules of Online Engagement:



- If you receive any unwanted/SPAM email to your County address, please forward the message directly to <u>spam@mono.ca.gov</u> and immediately delete the message. Do not forward it to IT or support.
- 2. We will all be receiving a lot of unsolicited email with links to special offers, tracking numbers for packages and shipments, and all kinds of other great things. As tempting as it is to just click on that convenient link in the email DON'T CLICK ON ANY LINKS IN AN EMAIL MESSAGE. The Best Practice is to copy the tracking number for a shipment and paste it into the company's own search tool, or open up a new web browser and navigate directly to the website who is providing the offer.

For those of us who will be shopping online, be thoughtful about who you are purchasing from.
Only buy from reputable companies, and never enter your credit card or other personal
information unless the webpage URL that you are connected to begins with https://
For more secure online shopping tips, visit https://www.us-cert.gov/ncas/tips/ST07-001

Between now and January 15th, expect a lot of spam to be coming through our filters and into County boxes. We do our best to minimize the exposure to spam, but can only do so much. Again, if you receive a message that you should not have, please forward it directly to spam@mono.ca.gov. Conversely, if you have not received an email and that you are expecting, it is possible that it was caught by our filter. To check on this, send an email to spamreport@mono.ca.gov in order to retrieve your blocked spam emails. In the subject line of the message include a number that corresponds to the number of days back in time you would like to get the report for (5 will give you the last five days).



Health Reform Resources - Answers to ACA Questions: The Kaiser Family Foundation released an updated collection of <u>Frequently Asked Questions</u> (FAQs) providing detailed answers for consumers, and the navigators and brokers who assist them. The searchable collection includes nearly 300 up-to-date responses, answering new questions about plan renewal, cancellations, and continuing financial assistance.

The FAQs also offer guidance for understanding 2014 federal income taxes in the context of the health law, addressing potential penalties for not obtaining coverage, exemptions to the individual mandate, and other subjects. Answers have been updated to key questions about how the law applies to the marketplace and Medicaid

eligibility, and offers guidance for immigrants, people with variable incomes and others in special situations.
