WHAT YOU NEED TO KNOW

YOU CAN STILL VOTE IN PERSON ON ELECTION DAY.

Polling places will be open on Election Day from 7 am to 8 pm. Please see the back cover of your Voter Information Guide for your polling location.

CHECK YOUR VOTER STATUS ONLINE

Visit the Secretary of State's My Voter Status page at www.voterstatus.sos.ca.gov, where you can check your voter status and find your polling place. You can:

- See if you are registered to vote, and in which county.
- Check your political party preference.
- Find your polling place.
- Find contact information for the elections office.
- Check the status of your vote-by-mail ballot or provisional ballot.

SAME DAY VOTER REGISTRATION

If you forgot to register or update your voter registration, you can register to vote and vote until 8 PM on Election Day. This process is called Conditional Voter Registration, also known as "Same Day Voter Registration." Just visit the elections office, or any polling place, complete a voter registration card or online application, and vote your ballot. Once we process your registration, and determine you are eligible to vote, you will be registered to vote and your ballot will be counted.

POSTAGE PREPAID BALLOTS

No Stamp, No Problem. All California vote-by-mail ballot return envelopes have prepaid postage, ensuring that voting is free and convenient for all California voters.

TWO US SENATE CONTESTS ON BALLOTS

There are two U.S. Senate contests on the November 5, 2024, General Election ballot.

- The first contest is the regular election for the full 6-year term ending January 3, 2031.
- The second contest is a special vacancy election (the current officeholder is temporarily filling a vacancy) for the remainder of the current term ending January 3, 2025.

You may vote for both contests.

To vote


To vote for a candidate, completely fill in the oval next to your choice.

Check both the front and the back of your ballot for voting contests.


Do not use red ink.



To vote for a qualified write-in candidate:

To vote for a write-in candidate, write the candidate's name in the blank space provided directly below the names of the other candidates for the office, then completely fill in the oval next to your choice.





Review your ballot:

If you vote for more candidates than allowed, or if you vote both Yes and No on a measure, your vote will not count for that contest. You do not have to vote on all contests. Those you do vote on will still count. If you make a mistake ask for another ballot.

All precincts in Mono County will have election materials available for voters in Spanish. You can request a Spanish translation of your ballot on Election Day at your polling location. MAMMOTH UNIFIED SCHOOL DISTRICT SCHOOL SAFETY AND IMPROVEMENT MEASURE

FULL TEXT OF BOND MEASURE

This measure may be known and referred to as the "Mammoth Unified School District School Safety and Improvement Measure" or as "Measure J".

BOND AUTHORIZATION

By approval of this measure by at least 55% of the voters of the Mammoth Unified School District (the "District") voting on the measure, the District shall be authorized to issue and sell bonds of up to \$70,000,000 in aggregate principal amount to provide financing for the specific school facilities projects listed under the heading entitled "BOND PROJECT LIST" below (the "Bond Project List"), and allow the District to qualify to receive potential State of California matching grant funds, subject to all of the accountability safeguards specified below.

ACCOUNTABILITY SAFEGUARDS

The provisions in this section are specifically included in this measure in order that the voters and taxpayers of the District may be assured that their money will be spent to address specific school facilities needs of the District, all in compliance with the requirements of Article XIIIA, Section 1(b)(3) of the Constitution of the State of California (the "California Constitution"), and the Strict Accountability in Local School Construction Bonds Act of 2000 (codified at Sections 15264 and following of the California Education Code).

Evaluation of Needs. The Board of Education of the District (the "Board") has evaluated the facilities needs of the District to determine which projects to finance from a local bond at this time. To address the facilities needs of the District, the Board deems it necessary and advisable to fund the specific school facilities projects listed in the Bond Project List. The Board hereby certifies that it has evaluated safety, class size reduction and information technology needs in developing the Bond Project List.

Limitations on Use of Bonds. Proceeds from the sale of bonds authorized by this measure shall be used only for the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, or the acquisition or lease of real property for school facilities, and not for any other purpose, including teacher and administrator salaries and other school operating expenses. More specifically, the Bond Project List provides for the specific projects the District proposes to finance with proceeds from the sale of bonds authorized by this measure and such proceeds shall be applied only to those specific purposes.

Independent Citizens' Oversight Committee. In accordance with and pursuant to California Education Code Section 15278 et seq., the Board shall establish an independent citizens' oversight committee, within 60 days of the

date that the Board enters the election results on its minutes pursuant to Section 15274 of the California Education Code, to ensure that (a) bond revenues are expended only for the purposes specified in Article XIIIA, Section 1(b)(3) of the California Constitution, and (b) that no funds are used for any teacher or administrative salaries or other school operating expenses. In accordance with Section 15282 of the California Education Code, the citizens' oversight committee shall consist of at least seven members and shall include a member active in a business organization representing the business community located within the District, a member active in a senior citizens' organization, a member active in a bona fide taxpayers' organization, a member that is a parent or quardian of a child enrolled in the District, and a member that is both a parent or quardian of a child enrolled in the District and active in a parent-teacher organization. The committee may be comprised of the same members of the citizens' oversight committees for other District bond measures. No employee or official of the District and no vendor, contractor or consultant of the District shall be appointed to the citizens' oversight committee.

Annual Performance Audits. In compliance with the requirements of Article XIIIA, Section 1(b)(3)(C) of the California Constitution, and the Strict Accountability in Local School Construction Bonds Act of 2000, the Board shall conduct an annual, independent performance audit to ensure that the proceeds from the sale of bonds authorized by this measure have been expended only on the school facilities projects listed in the Bond Project List. These audits shall be conducted in accordance with the Government Auditing Standards issued by the Comptroller General of the United States for performance audits. The results of these audits shall be made publicly available and shall be submitted to the citizens' oversight committee in accordance with Section 15286 of the California Education Code.

Annual Financial Audits. In compliance with the requirements of Article XIIIA, Section 1(b)(3)(D) of the California Constitution, and the Strict Accountability in Local School Construction Bonds Act of 2000, the Board shall conduct an annual, independent financial audit of the proceeds from the sale of bonds authorized by this measure until all of those proceeds have been spent for the school facilities projects listed in the Bond Project List. These audits shall be conducted in accordance with the Government Auditing Standards issued by the Comptroller General of the United States for financial audits. The results of these audits shall be made publicly available and shall be submitted to the citizens' oversight committee in accordance with Section 15286 of the California Education Code.

Special Bond Proceeds Account; Annual Report to Board. In compliance with the requirements of California Government Code Section 53410 and following, upon approval of this measure and the sale of any bonds approved, the Board shall take actions necessary to establish an account in which proceeds of the sale of bonds authorized by this measure shall be deposited. In compliance with the requirements of California Government Code Section 53411, as long as any proceeds of the bonds remain unexpended, the chief fiscal officer of the District shall cause a report to be filed with the Board at least once a year, stating (a) the amount of funds collected and expended in that year, and (b) the status of any project required or authorized to be funded from bond proceeds. The report may relate to the calendar year, fiscal year, or other appropriate annual period as the chief fiscal officer of the District shall determine, and may be incorporated into the annual budget, audit, or other appropriate routine report to the Board.

FURTHER SPECIFICATIONS

Single Purpose. All of the purposes enumerated in this measure shall be united and voted upon as one single measure, pursuant to California Education Code Section 15100, and all the enumerated purposes shall constitute the specific single purpose of the bonds, and the proceeds from the sale of bonds authorized by this measure shall be spent only for such purpose, pursuant to California Government Code Section 53410.

Other Terms of the Bonds. When sold, the bonds shall bear interest at an annual rate not exceeding the statutory maximum, and that interest shall be made payable at the time or times permitted by law. The bonds may be issued



and sold in several series, and no bond shall be made to mature more than the statutory maximum number of years from the date borne by that bond.

BOND PROJECT LIST

The Bond Project List below lists the specific projects the District proposes to finance with proceeds of the bonds. The Bond Project List shall be considered a part of this bond measure and shall be reproduced in any official document required to contain the full statement of the bond measure. Listed projects will be completed as needed at a particular school or school facility site according to Board-established priorities, and the order in which such projects appear on the Bond Project List is not an indication of priority for funding or completion. In so far as permitted by law, each project is assumed to include its share of costs of the election and bond issuance, construction-related costs, such as project and construction management, architectural, engineering, permitting and entitlements, inspection and similar planning and testing costs, demolition and interim housing costs, legal, accounting and similar fees, costs related to the independent annual financial and performance audits, a contingency for unforeseen design and construction costs, and other costs incidental to or necessary for completion of the listed projects (whether the related work is performed by the District or third parties). The final cost of each project will be determined as plans are finalized, construction bids are awarded, and projects are completed. In addition, certain project funds expected from non-local bond sources have not yet been secured. Therefore, the Board cannot guarantee that the bond proceeds will provide sufficient funds to allow completion of all listed projects. Alternatively, if the District obtains unexpected funds from non-local bond sources with respect to listed projects, such projects may be enhanced. supplemented or expanded to the extent of such funds. Some projects may be subject to further government approvals, including by State officials and boards and/or local environmental or agency approval, Inclusion of a project on the Bond Project List is not a guarantee that the project will be completed (regardless of whether bond funds are available).

The specific projects authorized to be financed with proceeds from the sale of bonds authorized by this measure are as follows:

MAMMOTH ELEMENTARY SCHOOL PROJECTS

The following projects are authorized to be financed at Mammoth Elementary School:

- Construct transitional kindergarten classrooms, restrooms and related facilities.
- Construct a field house and related amenities, including a track, restrooms and storage rooms, to hold recess, physical education classes and sports practices indoors.
- Acquire and install new flooring in the multi-purpose room.
- Construct a new playground area and acquire and install playground equipment, surface and fixtures for such playground.
- Renovate playfield and existing playground and replace existing playground equipment, surface and fixtures with new equipment, surface and fixtures.
- Repair, renovate and/or replace asphalt, concrete and other hard surfaces.
- Acquire and install heating, ventilation and air conditioning (HVAC) systems and equipment.
- Replace, renovate, acquire and/or install casework and other interior finishes.
- Improve, correct, restore and/or renovate grounds, buildings, and structures or portions thereof to eliminate or mitigate health and safety risks and/or comply with local, state and federal building, health, safety, access and other related requirements, including access requirements of the Americans with Disabilities Act (ADA).

MAMMOTH MIDDLE SCHOOL PROJECTS

The following projects are authorized to be financed at Mammoth Middle School:

- Replace roofs and remove leaking skylights.
- Update play areas, including relocating playground area and acquiring and installing new playground equipment, surface and fixtures.
- Acquire and install heating, ventilation and air conditioning (HVAC) systems and equipment.
- Repair, renovate and/or replace asphalt, concrete and other hard surfaces.
- Improve, correct, restore and/or renovate grounds, buildings, and structures or portions thereof to eliminate or mitigate health and safety risks and/or comply with local, state and federal building, health, safety, access and other related requirements, including access requirements of the Americans with Disabilities Act (ADA).

MAMMOTH HIGH SCHOOL PROJECTS

The following projects are authorized to be financed at Mammoth High School:

- Renovate site entrance to improve visitor access and campus security.
- Make campus safety improvements and ingress/egress, traffic flow, pick-up/drop-off and parking area improvements.
- Repair, renovate and/or replace asphalt, concrete and other hard surfaces.
- Acquire and install heating, ventilation and air conditioning (HVAC) systems and equipment.
- Make structural improvements to and/or retrofit existing gymnasium to meet current building codes.
- Install electric vehicle charging stations.
- Improve, correct, restore and/or renovate grounds, buildings, and structures or portions thereof to eliminate or mitigate health and safety risks and/or comply with local, state and federal building, health, safety, access and other related requirements, including access requirements of the Americans with Disabilities Act (ADA).

SIERRA HIGH SCHOOL PROJECTS

The following projects are authorized to be financed at Sierra High School and District Office:

- Acquire and install heating, ventilation and air conditioning (HVAC) systems and equipment.
- Improve, correct, restore and/or renovate grounds, buildings, and structures or portions thereof to eliminate or mitigate health and safety risks and/or comply with local, state and federal building, health, safety, access and other related requirements, including access requirements of the Americans with Disabilities Act (ADA).

EDUCATOR HOUSING PROJECTS

Acquisition and/or construction of rental housing units for teachers and staff, including:

- Acquisition of land and any rights-of-way and easements made necessary by construction and/or renovation of such facilities.
- Acquisition and renovation of existing housing units or buildings.
- Planning, designing, constructing and/or renovating such facilities.
- Associated onsite and offsite development and other improvements made necessary by construction of such facilities.
- Acquisition and installation of furnishings and equipment related to such facilities.



MISCELLANEOUS

All listed bond projects include the following as needed:

- Planning, designing and providing temporary housing necessary for listed bond projects.
- The inspection, sampling and analysis of grounds, buildings and building materials to determine the presence of hazardous materials or substances, including asbestos, lead, etc., and the encapsulation, removal, disposal and other remediation or control of such hazardous materials and substances.
- Seismic and historical evaluations, site surveys (including topographic, geological and utility surveys), and infrastructure analyses.
- Necessary onsite and offsite preparation or restoration in connection
 with new construction, renovation or remodeling, or installation
 or removal of relocatable buildings or other temporary buildings,
 including demolition of structures; removing, replacing, or installing
 irrigation, drainage, utility lines (gas, water, sewer, electrical, data and
 voice, etc.), trees and landscaping; and relocating fire access roads
 or ingress/egress pathways.
- Address other unforeseen conditions revealed by construction, renovation or modernization (including plumbing or gas line breaks, dry rot, seismic and structural deficiencies, etc.).
- Acquire or construct other improvements required to comply with building codes, including seismic safety requirements, the Field Act, and access requirements.
- Acquisition of any rights-of-way, easements, licenses and/or real property made necessary by listed bond projects, or lease of real property made necessary by the listed bond projects.
- Acquire or construct storage facilities and other space on an interim basis, as needed to accommodate construction materials, equipment, and personnel.
- Furnishing and equipping of classrooms and other school facilities; furnishing and equipping shall include initial purchases, and scheduled and necessary replacements, upgrades and updating of technology.
- All other costs and work necessary or incidental to the listed bond projects.

PROJECTS INVOLVING RENOVATION, REHABILITATION OR REPAIR

For any project involving renovation, rehabilitation or repair of a building or the major portion of a building, the District shall be authorized to proceed with new replacement construction instead (including any necessary demolition) if the Board of Education determines that replacement new construction is more practical than renovation, rehabilitation or repair, considering the building's age, condition, expected remaining life, comparative cost and other relevant factors.

GENERAL PROVISIONS

Interpretation. The terms of this bond measure and the words used in the Bond Project List shall be interpreted broadly to effect the purpose of providing broad and clear authority for the officers and employees of the District to provide for the school facilities projects the District proposes to finance with the proceeds of the sale of bonds authorized by this measure within the authority provided by law, including Article XIIIA, Section 1(b)(3) of the California Constitution, California Education Code Section 15000 et seq. and the Strict Accountability in Local School Construction Bonds Act of 2000. Without limiting the generality of the foregoing, such words as repair, improve, upgrade, expand, modernize, renovate, and reconfigure are used in the Bond Project List to describe school facilities projects in plain English and are not intended to expand the nature of such projects beyond, or have an effect on.

and shall be interpreted to only permit, what is authorized under Article XIIIA, Section 1(b)(3) of the California Constitution, California Education Code Section 15000 *et seq.* and the Strict Accountability in Local School Construction Bonds Act of 2000. In this regard, the Bond Project List does not authorize, and shall not be interpreted to authorize, expending proceeds of the sale of bonds authorized by this measure for current maintenance, operations or repairs. The school facilities projects on the Bond Project List only authorize capital expenditures.

Estimated Ballot Information. The Board hereby declares, and the voters by approving this bond measure concur, that the information included in the statement of the bond measure to be voted on pursuant to Section 13119 of the California Elections Code is based upon the District's projections and estimates only and is not binding upon the District. The amount of money to be raised annually and the rate and duration of the tax to be levied for the bonds may vary from those presently estimated due to variations from these estimates in the timing of bond sales, the amount of bonds sold and market interest rates at the time of each sale, and actual assessed valuations over the term of repayment of the bonds. The dates of sale and the amount of bonds sold at any given time will be determined by the District based on need for project funds and other factors. The actual interest rates at which the bonds will be sold will depend on the bond market at the time of each sale. Actual future assessed valuation will depend upon the amount and value of taxable property within the District as determined by the County Assessor in the annual assessment and the equalization process.

Headings. The headings or titles of the sections of the bond measure, including any headings or titles included in the Bond Project List, are solely for convenience of reference and shall not affect the meaning, construction or effect of the bond measure.

Severability. The Board and the voters hereby declare that every portion, section, subdivision, paragraph, clause, sentence, phrase, word, application and individual project (individually referred to as "Part" and collectively as "Parts"), of this bond measure has independent value, and the Board and the voters would have adopted each Part hereof regardless of whether any other Part of this bond measure would be subsequently declared invalid. Upon approval of this bond measure by the voters, should any Part of this bond measure be found by a court of competent jurisdiction to be invalid for any reason, all remaining Parts hereof shall remain in full force and effect to the fullest extent allowed by law, and to this end the Parts of this bond measure are severable.



IMPARTIAL ANALYSIS BY COUNTY COUNSEL MEASURE J

Measure J is proposed by the Board of Trustees ("Board") of the Mammoth Unified School District ("District"). Pursuant to the California Constitution and Education Code section 15266, a school district may issue general obligation bonds if approved by 55% (or more) of the voters of the District. This measure would authorize the District to issue and sell bonds up to \$70,000,000 in aggregate principal amount to provide financing for specific school facilities projects listed on the Bond Project List in the measure. Approval of the bond measure does not guarantee that all projects on the Bond Project List will be completed; some may be subject to approval by State officials and boards, and/or environmental of other agency approval. Inclusion of a project on the Bond Project List is not a guarantee that the project will be completed (regardless of whether bond funds are available). The Board has certified that it has evaluated the safety, class size reduction and information technology needs of the District in developing the Bond Project List.

The proceeds from these bonds may be used only for the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, or the acquisition or lease of real property for school facilities, and not for any other purpose, including teacher and administrator salaries and other school operating expenses.

By law the Board must establish an independent citizens' oversight committee to ensure that bond proceeds are properly expended for items in the Bond Project List. In addition, the Board must conduct annual, independent financial audits of the bond proceeds until all proceeds have been spent for the projects listed on the Bond Project List.

If the bonds are approved, the District expects to issue the bonds in multiple series over time. Principal and interest on the bonds will be payable from the proceeds of tax levies on taxable real property in the District. These taxes would be in addition to the normal property taxes levied on taxpayers in the District. The amount of the increased taxes each year will depend upon the amount needed to pay the principal and interest on the bonds.

According to the Tax Information Statement, the District estimates that the average annual tax rate that would be levied to fund this bond issue over the duration of the bond debt service is \$36.89 per \$100,000 (3.689 cents per \$100) of assessed valuation. The District estimates that the highest tax rate that would be levied to fund this bond issue is \$41.33 per \$100,000 (4.133 cents per \$100) of assessed valuation in fiscal year 2026-27. It is estimated that the final fiscal year that this tax would be collected is 2054-2055. These estimates and the years in which they apply may vary from those currently estimated due to the variations in the timing of bond sales, the amount of bonds sold and market interest rates at the time of each sale, and actual assessed valuations over the repayment term.

A "Yes" vote would permit the Board to issue bonds in an amount not to exceed \$70,000,000 to provide financing for the specific school facilities projects listed in the Bond Project List included in the measure.

A "No" vote would **not** permit the Board to issue bonds in an amount not to exceed \$70,000,000 to provide financing for the specific school facilities projects listed in the Bond Project List included in the measure.

TAX INFORMATION STATEMENT MESASURE J

An election will be held in the Mammoth Unified School District (the "District") on November 5, 2024, to authorize the sale of up to \$70,000,000.00 in bonds of the District to finance school facilities as described in the measure. If the bond measure is approved by at least 55% of the voters of the District voting on the bond measure, the District expects to issue the bonds in multiple series over time. Principal and interest on the bonds will be payable from the proceeds of tax levies made upon the taxable property in the District. The following information is provided in compliance with Sections 9400 through 9405 of the California Elections Code.

- 1. The best estimate of the average annual tax rate that would be required to be levied to fund this bond issue over the entire duration of the bond debt service, based on assessed valuations available at the time of filing of this statement, is \$36.89 per \$100,000 of assessed valuation. The final fiscal year in which the tax to be levied to fund this bond issue is anticipated to be collected is fiscal year 2054-55.
- 2. The best estimate of the highest tax rate that would be required to be levied to fund this bond issue, based on estimated assessed valuations available at the time of filing of this statement, is \$41.33 per \$100,000 of assessed valuation in fiscal year 2026-27.
- 3. The best estimate of the total debt service, including the principal and interest, that would be required to be repaid if all of the bonds are issued and sold is approximately \$130,535,869.00.

Voters should note that estimated tax rates are based on the ASSESSED VALUE of taxable property on the County's official tax rolls, <u>not</u> on the property's market value, which could be more or less than the assessed value. In addition, taxpayers eligible for a property tax exemption, such as the homeowner's exemption, will be taxed at a lower effective tax rate than described above. Property owners should consult their own property tax bills and tax advisors to determine their property's assessed value and any applicable tax exemptions.

Attention of all voters is directed to the fact that the foregoing information is based upon the District's projections and estimates only, which are not binding upon the District. The average annual tax rate, the highest tax rate, the final fiscal year in which the tax is anticipated to be collected and the year or years in which they will apply, and the actual total debt service, may vary from those presently estimated for a variety of reasons, including, without limitation, due to variations in the timing of bond sales, the amount or amortization of bonds sold, market conditions at the time of each sale, and actual assessed valuations over the term of repayment of the bonds. The dates of sale and the amount or amortization of bonds sold at any given time will be determined by the District based on need for project funds and other factors, including the legal limitations on bonds approved by a 55% affirmative vote. Market conditions, including, without limitation, interest rates, are affected by economic and other factors beyond the control of the District and will depend on the bond market at the time of each sale. Actual future assessed valuation will depend upon the amount and value of taxable property within the District as determined by the County Assessor in the annual assessment and the equalization process. The growth or decline in assessed valuation is the result of a number of economic and other factors outside the control of the District.

AN ORDINANCE OF THE MONO COUNTY BOARD OF SUPERVISORS AMENDING MONO COUNTY CODE SECTION 3.28.060 TO INCREASE THE TRANSIENT OCCUPANCY TAX RATE FROM TWELVE PERCENT TO FIFTEEN PERCENT

WHEREAS, Revenue and Taxation Code Section 7280 authorizes the board of supervisors of any county to levy in the unincorporated areas of the county a tax on the privilege of occupying a room or rooms, or other living space, in a hotel, inn, tourist home or house, motel, or other lodging unless the occupancy is for any period of more than 30 days or unless the occupancy is expressly exempt from such taxation by Section 7280 or other provision of state law; and

WHEREAS, such taxation is commonly referred to as "transient occupancy tax" or "TOT": and

WHEREAS, Mono County voters previously enacted The Tourists' Fair Share Act in Mono County Code Chapter 3.28, which currently levies a transient occupancy tax of 12% of the nightly rent charged; and

WHEREAS, the County provides essential services such as affordable and workforce housing, economic diversification and development, public safety and emergency services, road maintenance and pothole repair, public health and healthcare, and maintenance of county parks; and

WHEREAS, tourists make use of essential county services, such as parks, emergency response, and roads; and

WHEREAS, tourism, while critically essential to Mono County's economy, has contributed to the lack of affordable and workforce housing for those living and working in Mono County; and

WHEREAS, an increase in the transient occupancy rate by 3%, from 12% to 15% would raise an additional \$1.1 million in general fund revenues to supplement County services, including affordable and workforce housing development; and

WHEREAS, the County seeks to amend Chapter 3.28 of the Mono County Code to enact such an increase to the transient occupancy rate.

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF MONO ORDAINS that:

SECTION ONE: Section 3.28.060 of the Mono County Code is hereby amended to read as follows:

"For the privilege of occupancy of any transient occupancy facility, each transient is subject to and shall pay a tax in the amount of fifteen percent of the rent charged. The tax constitutes a debt owed by the transient to the county which is extinguished only by payment to the operator or to the county. The transient shall pay the tax to the operator of the transient occupancy facility at the time the rent is paid. If the rent is paid in installments, a proportionate share of the tax shall be paid with each installment. The unpaid tax shall be due upon

the transient's ceasing to occupy space in the transient occupancy facility. If for any reason the tax due is not paid to the operator of the transient occupancy facility, the tax collector may require that such tax shall be paid directly to the tax collector."

SECTION TWO: Pursuant to California Constitution Article XIIIC Section 2(b) and California Elections Code Section 9141, this Ordinance shall take effect only if approved by a majority of the eligible voters of the County of Mono voting in the General Election to be held on November 5, 2024 and shall become effective 10 days after the results of said election are certified by the Board of Supervisors.

IMPARTIAL ANALYSIS BY COUNTY COUNSEL MEASURE K

Under the California Constitution and related state laws, local governments may levy a general tax if it is submitted to and approved by at least a majority of the voters within its jurisdiction.

The Mono County Board of Supervisors submitted Measure K, which, if approved, would increase the Transient Occupancy Tax ("TOT") levied in the unincorporated areas of Mono County from 12% to 15%. TOT is a tax charged to guests of hotels, motels, and similar short-term lodging who stay for a period of less than 30 days. Hotel and other transient accommodation operators collect the TOT when guests pay for their accommodations and transmit that TOT to Mono County.

The TOT increase proposed by Measure K is a general tax, meaning that the revenue generated by the tax would be deposited into the Mono County general fund and may be used for any general governmental purpose. These include, but are not limited to, essential county services such as development of affordable housing, public health and healthcare services, emergency response, street maintenance and repair, public safety, and economic development.

Currently, TOT generates approximately \$4,400,000 in general fund revenues for Mono County. Measure K, if passed by a majority of voters, would generate approximately \$1,100,000 in additional general fund revenue annually.

A "yes" vote on Measure K is a vote to increase the Transient Occupancy Tax rate charged to hotel and transient lodging guests in unincorporated Mono County from 12% to 15%.

A "no" vote on Measure K is a vote to leave the Transient Occupancy Tax rate at 12%.

The above statement is an impartial analysis of Measure K submitted by the Office of the Mono County Counsel.



FISCAL IMPACT STATEMENT FOR MEASURE K

This measure provides for an increase in the Transient Occupancy Tax (TOT) in the unincorporated area of Mono County. The TOT is a tax imposed upon those individuals staying overnight at lodging facilities. And since the tax is generally imposed upon visitors, this additional local tax burden is not imposed on residents of Mono County. Currently, the tax is 12% of the room charge, usually paid when the transient occupies the room. This ballot measure would increase the TOT from 12% to 15%, effective ten days after certifying the election results for a majority "yes" vote. The increase in the TOT tax would result in an additional \$1.1 million in General Fund revenue annually, which would be available to pay for general County services and programs. The tax remains in effect until voters change it.

The TOT in the unincorporated area of the County generated an annual average of \$3.3 million since the fiscal year ended June 30, 2012, for the County General Fund, with a low of \$2.4 million during the fiscal year 2012-13 and a high of \$4.0 million during the fiscal year 2022-23. Revenue from the TOT is the County's second-largest source of discretionary tax, following property taxes.

ARGUMENT IN FAVOR OF MEASURE K

Mono County faces a critical shortage of affordable and workforce housing. All of the funds from Measure K would be spent right here in Mono County and can't be taken by the State.

Please join us in voting YES on Measure K, and help our county reinvest in housing and services to support our Mono County residents.





Accessible Voting

At the Polling Place

All Pollng Places are ADA Accessible. Poll Workers are available to assist.

A poll worker may also take a regular ballot to the physically handicapped person at a place as near as possible to the polling place and which is accessible to such person, qualify that person to vote, and return the voted ballot to the polling place (EC 14282). If you are unable to mark your ballot, you may bring up to two people to the polls to assist you with voting. This person cannot be your employer or anyone who works for your employer, nor your labor union leader or anyone who works for your labor union.



Accessible Voting System

Each Polling Place has a ballot marking device that offers:

- An audio option that reads the ballot to you.
- A handheld tactile device with a universal plug for a personal assistive device.
- Large text size.

Instructions for Voters Requesting an RAVBM Ballot

Voters who are disabled, can't leave their home, have a hard time filling out their ballot, or who wish to vote remotely can request a Remote Accessible Vote by Mail Ballot (RAVBM). An RAVBM ballot is emailed to the voter to download, print, fill out by pen, and mail back to our office to be counted.
