## Vote-By-Mail Ballot Return Options:

-  Return by mail using your yellow Postage Prepaid Return Envelope.
-  Return in person at the Mono County Elections office.
-  Drop off in one of six ballot drop boxes located throughout the County, or any drop box in the State of California.
-  Drop off at any polling place or vote center within the State of California.



## ***Follow the below instructions for your vote to be counted:***

### **To vote:**

Completely fill in the oval next to the choice you want to select as your vote.



### **Important:**

Check both the front and the back of your ballot for voting contests. Use blue or black pen only. Other colors or pencil may not be tallied.

### **Review your ballot:**

- If you vote for more options than allowed, or if you vote both options on a measure, your vote will not count for that contest.
- You do not have to vote on all contests. Those you do vote on will still count.
- If you make a mistake on your ballot:
  - You may request a new ballot by calling the elections office at 760-932-5537. Replacement mailed ballots request deadline is 05/26/26. **or**
  - You may also fix your mistake by drawing a line through the unintended choice and mark the oval you intended. **If your selection is obvious, it will be counted!**

### **Spanish Language Assistance:**

All precincts in Mono County will have election materials available for voters in Spanish. You can request a Spanish translation of your ballot on Election Day at your polling location. Bilingual poll workers and phone translation services in many languages will be available to assist you if needed. ## California's Top-Two Primary

**All registered voters can vote in the June 2, 2026, Statewide Direct Primary Election regardless of political party affiliation.**

### **Voter-Nominated Offices**

The Top Two Candidates Open Primary Act requires that all candidates for a voter-nominated office be listed on the same ballot.

- U.S. Senator
- U.S. Representative in Congress
- State Senator\*
- State Assembly Member
- State Constitutional Offices
  - Governor, Lieutenant Governor, Secretary of State, Controller, Treasurer, Attorney General, Insurance Commissioner, and Member of the State Board of Equalization

The candidate's party preference (or "None") appears on the ballot but does not necessarily represent the party's endorsement. Parties may list the candidates who have received the party's official endorsement in the County Voter Information Guide.

The two candidates with the most votes in their contest face each other in the General Election. They may or may not have the same party affiliation.

Write-in candidates can run in the Primary Election. However, a write-in candidate can move on to the General Election only if the candidate is one of the top two vote-getters. There is no independent nomination process for the General Election.

### **Nonpartisan Offices**

A candidate's party affiliation never appears on the ballot for nonpartisan offices.

- Judicial Offices\*
- State Superintendent of Public Instruction
- County Superintendent of Schools
- County Board of Supervisors
- County Offices
  - Assessor, District Attorney\*, and Sheriff-Coroner\*

The candidate who receives the majority of votes wins. If no candidate gets more than 50% of the vote, the two candidates with the most votes move to the General Election in a run-off. For judges, the top vote-getter wins, and there is no run-off.

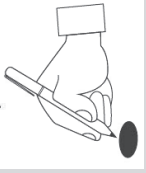

# Ballot Information for this Election:

## June 2, 2026, Statewide Direct Primary Election

### Non-Partisan

Positions such as judges and county supervisors are “Non-Partisan” Offices and are included on the primary ballot without any party labels. Candidates are not allowed to list party preferences, and political parties cannot nominate or endorse them in the formal process. All voters can participate regardless of party registration. In each contest, if a candidate receives simple majority of votes win outright in the Primary. If no candidate receives a majority of the vote, then the top two vote-getters move on to the General Election for a run-off.

### Voter-Nominated

Positions such as U.S. Congressional seats, State Assembly and Senate, and statewide constitutional offices such as Governor, Lt. Governor, SOS, Treasurer, etc. are “Voter-Nominated” Offices. In this system, all candidates for a voter-nominated office—regardless of party preference—appear on the same primary ballot, and all voters may choose any candidate regardless of their own party registration. The two candidates receiving the highest number of votes then advance to the November general election, and a general election is always required even if a candidate receives more than 50 percent of the primary vote.

### Political Party Endorsements

Parties have the option of submitting candidate endorsements for printing in this pamphlet. Not all parties participate, and parties may endorse a candidate from another party. **RESOLUTION NO. (25/26) - 11**

**RESOLUTION OF THE BOARD OF EDUCATION OF THE  
MAMMOTH UNIFIED SCHOOL DISTRICT CALLING FOR  
VOTER APPROVAL OF A REPLACEMENT QUALIFIED  
SPECIAL TAX AND ESTABLISHING SPECIFICATIONS OF  
THE ELECTION ORDER**

**RESOLVED** by the Board of Education (“**Board**”) of the Mammoth Unified School District (the “**District**”), a District of the County of Mono, State of California that:

**WHEREAS**, the Board believes that a qualified special tax is necessary to continue to support high academic achievement for all District students by offering and providing high-quality educational programs; and

**WHEREAS**, Section 4 of Article XIII A and Section 2 of Article XIII C of the California Constitution, and Sections 50075, 50079, and 53722 et seq. of the California Government Code (“**Government Code**”), authorize a school district, upon approval of two-thirds of the voters voting on the measure, to levy a qualified special tax for specified purposes; and

**WHEREAS**, an adequately funded and well-developed public education program provides numerous benefits and advantages to students, families, and residents of the community; and

**WHEREAS**, funding from the State of California and the Federal Government has been inadequate and uncertain to fully meet the District’s educational objectives, and the Board has no assurance that future State or Federal funding will permit the District to meet those objectives; and

**WHEREAS**, over the past several years, the Board has made every effort to reduce District expenditures in a manner that does not adversely impact important academic programs necessary to support a high-quality curriculum for all District students; and

**WHEREAS**, residents of the District have demonstrated support since 2003 for locally controlled funding measures to maintain high-quality academic programs, attract and retain qualified educators, and provide stable funding for District schools; and

**WHEREAS**, on November 3, 2020, voters of the District approved Measure “G”, a qualified special tax measure, by more than two-thirds of the votes cast, authorizing the levy of a qualified special tax to support District educational programs; and

**WHEREAS**, the qualified special tax approved by the voters as Measure “G” will otherwise expire on June 30, 2027, unless renewed, replaced, or continued by approval of the voters; and

**WHEREAS**, the Board has determined, following noticed public hearings and community input, that in order to maintain and improve the quality of education in the District and to continue providing stable, locally controlled funding for District schools, it is advisable and necessary to submit to the voters the question of whether the District shall replace the existing qualified special tax; and

**WHEREAS**, if approved by the voters, proceeds from the new qualified special tax would continue to be used for educational purposes authorized by Measure “G”, including attracting and retaining teachers and staff, supporting academic programs, and maintaining accountability measures such as independent citizen oversight and annual reporting; and

**WHEREAS**, the Governing Board is committed to allocating at least 10 percent of any received tax revenue from the new qualified special tax for the purpose of maintaining extracurricular activities and athletic programs; and

**WHEREAS**, the Board is authorized to order elections within the District and to designate the specifications thereof pursuant to Sections 5304 and 5322 of the California Education Code (“**Education Code**”), and authority for ordering the election is contained in Section 4 of Article XIII A of the California Constitution; and

**WHEREAS**, the Board now desires to order the calling of an election to be held on June 2, 2026, for the purpose of submitting to the voters of the District a measure to create the qualified special tax, replacing Measure G, and to authorize the filing of a ballot argument in favor of the measure; and

**WHEREAS**, pursuant to Education Code section 5342 and applicable Elections Code provisions, such election may be consolidated with any other election held on the same date in the same territory or in territory that is in part the same.

**NOW, THEREFORE**, be it further resolved, determined and ordered by the Board of Education of the Mammoth Unified School District, as follows:

**Section 1. Recitals.** The foregoing recitals are true and correct and are incorporated herein by this reference.

**Section 2. Election Ordered; Purpose.** That the Board has determined in its best judgment that in order to maintain quality education in the District, an election is advisable and on that basis hereby orders the Mono County Registrar of Voters to call an election and submit to the voters of the District the question of whether to adopt a qualified special tax for the educational purposes and to increase the District’s appropriations limit in an amount equal to the levy of the special taxes for a period of seven (7) years as permitted by Article XIII B of the California Constitution, all as described further below.

**Section 3. Rate of Special Tax.** The special tax (“**Special Tax**”) shall be levied against each taxable parcel of real property located wholly or partially within the boundaries of the District at the rate authorized under Measure attached hereto as **Exhibit A**, as adjusted and administered in accordance with the provisions set forth in **Exhibit A** attached hereto and incorporated herein by this reference.

The proceeds of the special tax will be applied to the following educational purposes:

- Enhance math and science classes
- Provide students with books and supplies
- Attract and retain qualified, high-performing teachers
- Provide updated technology, including software, hardware and support



- Keep class size small for early grades
- Enhance student counseling programs
- Maintain library staff and services
- Maintain and enhance District language programs
- Maintain and enhance the District music, arts and enrichment programs
- Maintain extracurricular activities and athletic programs
- Maintain and advance needed educational programs

The Board will not fund any program other than those listed above from the proceeds of the special tax. The Board of Education will allocate at least 10% of the annual parcel tax proceeds to maintaining extracurricular activities and athletic programs.

**Section 4. Annual Adjustment of Rate.** Beginning on July 1, 2027, and each year thereafter, the rate of the Parcel Tax shall be increased from the rate levied in the prior tax year by a cost-of-living adjustment equal to the annual percentage change in the California Consumer Price Index – All Urban Consumers over the prior twelve months, as of December 1 of the prior fiscal year, as published by the State of California Department of Industrial Relations. If, in any given year, that index is not available, then the rate will be adjusted based on the changes in the Consumer Price Index – All Urban Consumers (CPI-U) West Region published by the U.S. Bureau of Labor Statistics.

**Section 5. Definition of Parcel; Exempt Property.** As used herein, the term “parcel” shall mean any unit of land with an Assessor’s Parcel Number (“APN”) located wholly or partially within the boundaries of the District that receives a separate property tax bill from the County of Mono. All property that would otherwise be exempt from ad valorem property taxation shall also be exempt from the Special Tax.

**Section 6. Election Date.** The election shall be held on June 2, 2026.

**Section 7. Measure Text; Exhibits.** The purpose of the election shall be for the voters of the District to vote on a ballot measure (the “Measure”) authorizing the Special Tax, a full copy of which is attached hereto as **Exhibit A** and incorporated herein by this reference. As required by California Elections Code section 13247, the abbreviated form of the Measure to appear on the ballot is attached hereto as **Exhibit B** and incorporated herein by this reference.

**Section 8. Authority to Order Election.** The Board has authority to order the election pursuant to Article XIII A, section 4 of the California Constitution; Government Code sections 50075 through 50079 and 53722 et seq.; and Education Code sections 5304 and 5322.

**Section 9. Order to Registrar.** This Resolution shall stand as the order of the Board to the Mono County Registrar of Voters to call and conduct the election within the boundaries of the District on the Election Date.

**Section 10. Filing and Delivery of Resolution.** The Clerk or Secretary of the Board is hereby requested and directed to deliver certified copies of this Resolution to the Mono County Registrar of Voters, the Mono County Clerk, the Mono County Board of Supervisors, and the Mono County Superintendent of Schools so that they are received within the time required by law.

**Section 11. Formal Notice of Election.** The Mono County Superintendent of Schools is hereby requested to prepare and execute a Formal Notice of School Parcel Tax Election and to publish and/or post such notice as required by law, and to perform the duties under Education Code section 5302 in connection with the election ordered hereby.

**Section 12. Conduct of Election.** Pursuant to Education Code section 5303, the Mono County Registrar of Voters is hereby requested to take all steps incident to the preparation for and holding of the election in accordance with law and these specifications and to deliver copies of all published notices to the Clerk or Secretary of this Board pursuant to Elections Code section 12113.

**Section 13. Consolidation; Canvass.** In accordance with Education Code section 5342 and Elections Code section 10402.5, it is hereby requested that the election ordered by this Resolution be consolidated with any and all other elections to be held on the same date within the District. The Mono County Board of Supervisors is authorized to canvass the returns of the election pursuant to Elections Code section 10411.

**Section 14. Required Vote.** Pursuant to Article XIII A, section 4 of the California Constitution, the Measure shall become effective only upon approval by at least two-thirds of the voters voting on the proposition.

**Section 15. Collection and Administration of Continued Tax.** Upon voter approval, the Special Tax shall become effective as of July 1, 2026, shall replace Measure G, and shall be collected by the Mono County Tax Collector at the same time, in the same manner, and subject to the same penalties as general ad valorem property taxes. Any delinquent Special Tax and penalty shall bear interest at the same rate as unpaid ad valorem property taxes until paid.

**Section 16. Exemptions.** Homeowners age sixty-five (65) and over shall continue to be eligible for exemptions from the Special Tax pursuant to Government Code section 50079 and procedures adopted by the Board as specified in **Exhibit A**.

**Section 17. Accountability.** The members of the Board, the Superintendent of the District, and officers of the District are hereby requested and directed, individually and collectively, to provide accountability measures pursuant to Government Code Section 50075.1 that include, but are not limited to, (a) a statement indicating the specific purposes of the Special Tax, (b) a requirement that the proceeds be applied only to the specific purposes identified pursuant to subsection (a), (c) the creation of an account into which the proceeds shall be deposited, and (d) an annual report pursuant to Section 50075.3 of the Government Code. To ensure additional accountability, an independent community oversight committee shall be appointed by the Board to oversee the activity of the proceeds as approved by the voters. The oversight committee shall be comprised of one Board member, the Superintendent of the District, the Chief Business & Financial Officer of the District, two teachers, parents, and community members, totaling not more than ten (10) members.

**Section 18. Annual Report.** Pursuant to Section 50075.3 of the Government Code, the Board directs that the Chief Business & Financial Officer of the District file a report with the Board no later than January 1, 2027, and at least once a year thereafter. The annual report shall contain both of the following: (a) The amount of funds collected and expended, and (b) the status of any project required or authorized to be funded as provided in this resolution.

**Section 19. Further Authorization.** The members of the Board, the Superintendent of the District, and officers of the District are hereby authorized and directed, individually and collectively, to do any and all things and to execute, deliver, and perform any and all documents they deem necessary or advisable in order to effectuate the purposes of this Resolution, including, without limitation, to prepare and submit for inclusion in the voter information pamphlet an argument in favor of passage of the ballot measure. All actions heretofore taken by the officers and agents of the District that are in conformity with the purposes and intent of this Resolution are hereby ratified, confirmed, and approved in all respects.

**Section 20. Severability.** The Board hereby declares, and the voters by approving the Measure concur, that every section and part of this



Resolution and the Measure has independent value, and that the Board and the voters would have adopted each provision regardless of every other provision. If any part is found invalid, the remaining provisions shall remain in full force and effect to the fullest extent allowed by law.

**Section 21. Effective Date.** This Resolution shall take effect immediately upon its adoption.

## EXHIBIT A

### FULL TEXT OF THE SPECIAL TAX MEASURE FOR MAMMOTH UNIFIED SCHOOL DISTRICT

This Measure may be known as Measure N.

To maintain high quality programs at all Mammoth schools with funds that cannot be taken by the State and spent elsewhere, shall Mammoth Unified School District's replacement parcel tax to preserve smaller classes, attract and retain experienced teachers, strengthen core curriculum, and enhance technology, art, music, math, science and athletic programs be adopted at \$99 per parcel raising \$1.1 million annually for seven years with annual inflation adjustments, independent oversight, audits, and exemptions for senior citizens' primary residences.

#### **PURPOSE**

To provide local revenue that cannot be taken by the State and to maintain high-quality public education in schools in the Mammoth Unified School District (the "District"), the District proposes to levy and collect an education parcel tax annually for 7 years as more fully described below under "EDUCATION PARCEL TAX AND PROCEDURES," and to implement accountability measures in connection with the education parcel tax and to provide oversight and accountability to ensure that funds are used only for the following specific purposes:

- Enhance math and science classes
- Provide students with books and supplies
- Attract and retain qualified, high-performing teachers
- Provide updated technology, including software, hardware and support
- Keep class size small for early grades
- Enhance student counseling programs
- Maintain library staff and services
- Maintain and enhance District language programs
- Maintain and enhance the District music, arts and enrichment programs
- Maintain extracurricular activities and athletic programs
- Maintain and advance needed educational programs

The Board of Education will not fund any program other than those listed above from the proceeds of the education parcel tax. The Board of Education will allocate at least 10% of the annual parcel tax proceeds to maintaining extracurricular activities and athletic programs.

#### **EDUCATION PARCEL TAX AND PROCEDURES**

##### Amount of Education Parcel Tax.

Subject to two-thirds approval of the voters, the education parcel tax of \$99 per parcel (except exempt parcels, as described below) shall be effective for 7 years commencing with fiscal year 2026-27 and be collected by the Mono County Tax Collector at the same time as and along with, and shall be subject to the same penalties as general ad valorem taxes collected by said tax collector.

The existing qualified special tax approved by voters as Measure G in 2020 shall cease to be levied after June 30, 2026. This Measure will replace the existing Measure G, and the Measure G qualified special tax shall not be collected in any year in which this Measure is collected. In the event this Measure is not approved, the existing Measure G qualified special tax shall continue in effect until its scheduled expiration date.



Definition of Parcel.

A parcel shall be defined as any unit of land in the District that receives a separate tax bill from the Mono County Tax Collector's Office.

Exemptions.

The following exemptions shall apply to the levy of the qualified special tax.

- Otherwise Exempt Property. All property that would otherwise be exempt from property taxes shall also be exempt from the education parcel tax.
- Senior Citizen Exemption. An exemption shall be available to persons who are 65 years or older and own and occupy as a principal residence a parcel subject to the education parcel tax.

Property owners seeking the senior citizen exemption must apply to the District for such exemption under procedures established by the District or otherwise as required by law or by the Mono County Tax Collector. However, property owners who have already qualified for a senior citizen exemption under the District's current parcel tax measure approved by voters in November 2020 will be automatically qualified for an exemption under this measure.

Exclusive Procedures.

The procedures described herein with respect to the levy and collection of the education parcel tax and exemptions, and any additional procedures established by the Board of Education of the District, shall be the exclusive claims procedure for claimants seeking an exemption, refund, reduction, or re-computation of the qualified special tax. Whether any particular claim is to be resolved by the District or by the County shall be determined by the District, in coordination with the County as necessary. The District's Board of Education may adopt such additional or supplemental procedures as it deems necessary or convenient for the administration of the education parcel tax.

**ACCOUNTABILITY MEASURES**

Government Code Accountability.

In accordance with the requirements of California Government Code sections 50075.1 and 50075.3, the following accountability measures, among others, shall apply to the qualified special taxes levied in accordance with this Measure:

- the specific purposes of the education parcel tax shall be those purposes identified above under the heading "PURPOSES,"
- the proceeds of the education parcel tax shall be applied only to those specific purposes identified above under the heading "PURPOSES,"
- a separate, special account shall be created into which the proceeds of the education parcel tax must be deposited; and
- the Chief Business & Financial Officer of the District shall file an annual written report with the Board of Education of the District showing (1) the amount of funds collected and expended from the proceeds of the education parcel tax and (2) the status of any projects, programs, or purposes identified above under the heading "PURPOSES."

Citizens' Oversight Committee.

In addition to the accountability measures required by the Government Code, an independent Citizens' Oversight Committee shall be appointed by the Board of Education to advise the Board on the expenditures funded by the measure

in order to ensure that said funds are spent for the purposes approved by the voters. The Citizens' Oversight Committee will monitor the expenditures of these funds by the District and will report on an annual basis to the Board and community on how these funds have been spent.

Annual Independent Audits.

The District will engage a third-party independent auditor to conduct annual audits reviewing the revenues and expenditures of the education parcel tax to confirm that funds are spent for the purposes described in the measure.

**PROTECTION OF FUNDING**

Current law forbids any decrease in State or Federal funding to the District because of the District's adoption of an education parcel tax. However, if any such funds are reduced because of the adoption of this education parcel tax, then the amount of the education parcel tax will be reduced annually as necessary in order to restore such State or Federal funding.

**PROTECTION OF FUNDING**

Funds generated by this Special Tax shall remain under local control and shall not be taken by the State of California. If the State or Federal Government reduces funding to the District as a result of this Measure, the Special Tax rate shall be reduced as necessary to restore such funding levels.

**SEVERABILITY**

The Board, and the voters by approving this Measure, declare that each section and part of this Measure has independent value. If any portion is held invalid by a court of competent jurisdiction, the remaining portions shall remain in full force and effect to the fullest extent permitted by law.



## IMPARTIAL ANALYSIS OF MEASURE N

This analysis was prepared by the Mono County Counsel.

Measure “N” would authorize the Mammoth Unified School District (“the District”) to levy a special parcel tax to replace the District’s existing Measure “G” parcel tax, which expires in 2027. A “parcel” is defined as any unit of land that receives a separate property tax bill from the County.

### The Proposed Tax

If approved, Measure “N” would authorize a tax of **\$99 per parcel, per year, for seven years**, beginning July 1, 2026, and ending June 30, 2033. The District estimates the tax would generate approximately **\$1.1 million annually**. Starting July 1, 2027, the tax rate would be adjusted annually for inflation based on the California Consumer Price Index.

A “YES” vote on this measure is a vote to authorize the tax. A “NO” vote is a vote to not authorize the tax. If Measure “N” fails, the existing Measure “G” tax will continue until it expires. Passage of Measure “N” requires approval by two-thirds (66.67%) of the voters.

### Use of Tax Revenue

Revenue from this tax can only be used for specific educational purposes and cannot be taken by the state. The measure requires the District to use the funds for purposes including:

- Attracting and retaining qualified teachers
- Keeping class sizes small in early grades
- Enhancing math, science, arts, and music programs
- Maintaining extracurricular and athletic programs
- Providing updated technology, books, and supplies

The measure specifically requires that at least 10% of annual proceeds be used for maintaining extracurricular and athletic programs.

### Tax Exemptions

Measure “N” provides two exemptions from the tax:

1. An exemption for any parcel owned and occupied as a primary residence by a person aged 65 or older. Property owners who already receive the senior exemption for Measure “G” will be automatically exempted from Measure “N” without reapplying.
2. An exemption for any property that is otherwise exempt from *ad valorem* property taxes, such as properties owned by government agencies.

The measure does not include exemptions based on income or for persons receiving Supplemental Security Income disability benefits.

### Accountability and Oversight

The measure requires specific accountability provisions. All tax revenue must be deposited into a separate account. The District must conduct annual independent audits and publish an annual public report detailing the amount of funds collected and spent, and the status of funded programs. The measure also requires the creation of an independent Citizens’ Oversight Committee, appointed by the School Board, to monitor expenditures and report its findings to the public.

## MAMMOTH UNIFIED SCHOOL DISTRICT ARGUMENT IN FAVOR OF MEASURE N

What makes Mammoth different is simple: when something matters, we handle it ourselves. And when it comes to our children’s education, nothing matters more. Since 2003, Mammoth residents have supported their local schools through a parcel tax, renewing it four times, because the state refuses to fund our schools the way they deserve.

But here’s the truth: that parcel tax has never been increased. The same \$59 rate approved over twenty years ago has lost nearly half its purchasing power to inflation. Programs we once funded have been cut because the dollars simply don’t stretch as far as they used to.

Measure N replaces the existing parcel tax at \$99 per parcel - reclaiming much of what inflation has eroded - and restores funding for the programs our kids depend on.

Measure N will protect our schools by:

- Enhancing math, science, technology, arts, and music programs
- Keeping small class sizes in early grades
- Maintaining extracurricular activities and athletic programs
- Attracting and retaining qualified, high-performing teachers
- Providing high quality academic programs

This is a local measure that puts local families in control. All money stays here - it cannot be taken by the State. An independent citizens’ oversight committee of parents, teachers, and community members will ensure every dollar is spent only on voter-approved programs. Annual independent audits provide additional accountability. Senior citizens age 65 and older who own and occupy their homes qualify for an exemption.

We have supported our schools for more than two decades because we know strong schools build a strong community. Now it’s time to do it again - because our children deserve the best, and that’s never been more true than today.

## Mismatched signatures

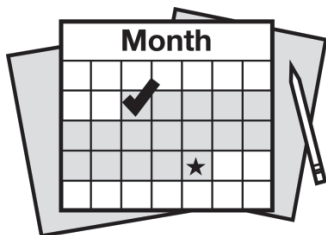
Voter's signature must look similar to the signature on the voter's registration card.

- Large text size with three viewing versions



## Instructions for Voters Requesting a Remote Ballot (RAVBM)

The RAVBM system allows voters with disabilities to download and mark their ballot privately and independently using their own assistive technology at home. Print a marked ballot and return it to the Elections Division to be counted. For additional information please visit <https://monocounty.ca.gov/elections/page/remote-accessible-vote-mail-ravbm>.

To request a RAVBM ballot, send an email to [elections@mono.ca.gov](mailto:elections@mono.ca.gov). Include with your request the following information: Full name, date of birth, home address, and mailing address.

NOTICE - This option is available to ALL voters.

## Curbside Voting

If a voter cannot easily enter a polling place, they have an option to vote from their vehicle. Poll workers will check the voter in, bring them voting materials, and return the voted ballot to the ballot box. Phone numbers are provided in selected parking spots at each polling place.

## Signing Election Documents

If you are unable to sign your own name and have no other legal mark, make an "X," if possible, on the signature line. If you are unable to make an "X," you must indicate in some manner to the person assisting you that you want to sign your name. The person helping you must sign an election form and attest that you indicated that you want to sign the election form.
