

## NOTICE OF PUBLIC INFORMATION MEETING

This public notice was prepared pursuant to Title 27 California Code of Regulations §21660.3(b) for new solid waste facilities permit applications.

(1) Name and location of the facility: MAMMOTH LAKES TRANSFER STATION, 59 Commerce Drive, Mammoth Lakes, CA

(2) Solid waste facilities permit/facility number : 26-AA-0013

(3) Purpose: To provide interested parties the opportunity to become informed about the changes being proposed and the actions being taken by the enforcement agency in processing the permit.

(4) Date the EA accepted the solid waste facilities permit revision application: May 6, 2022.

(5) Description of proposed changes to the solid waste facilities permit:

- Increase maximum daily tonnage from 15 tons per day to 500 tons per day,
- Establish items not included in previous notification: maximum vehicles per day at 400,
- Establish operating documents not required as part of previous notification: describe operations and limits related to processing and waste acceptance.

(6) EA's preliminary determination: The preliminary determination is to accept the new permit application as complete and prepare a new permit and issue it following concurrence by the California Department of Resources Recycling and Recovery (CalRecycle).
