First Impressions:

- These tiles were installed 15+ years ago, probably closer to 20. Does anyone know for sure?
- Just painting Pickle ball lines to existing surface (approx. ~\$1,650)...but the strong recommendation would be to put the new SportGame Pickle ball/Tennis surfacing in, replace/update the basketball hoops, replace footings/set new sleeves for tennis posts.
- These tiles would need to be replaced, concrete prepped underneath, footings for poles removed and redone, and new surfacing installed.
- This would offer Tennis, Pickle ball, Volleyball (if we use the taller poles), and two Basketball hoops with lines for all of these sports. Currently has Shuffle Board Is that a desire with a new court?
- Barrett is working on a quote for us. FYI Mono County and Mono County Public Works are signed up with Sourcewell and are already making purchases off the Sourcewell Purchasing Agreement.
