Supervisor Gardner:

- Housing update: Acorns (John Head), project has challenges, still progressing just more slowly
- Don Morton plan: will keep updated
- June Lake Chamber of Commerce proposes TBID, beginning to engage with consultants to specify, not contracted yet.
- Interest in creating disc golf course, Sierra Nevada Conservancy possibly interested in providing grant funding.
- June Lake Chamber: Balanced Rock project. Some sort of monument, safe parking, etc.. Possibly locating monument on trailhead side of road to reduce crossings.
- Some flooding at community center. Replacing windows in thrift shop.
- Is June Lake interested in existing Mammoth Donut (fuels treatment project), or proceed independently?.
- Charge Point project at High Sierra: No progress yet. John set up meeting for Jan 5.

Discussion of hybrid meetings:

- After feb. 28, state of emergency ends, also ending AB 361, which allowed zoom meetings.
 - Can either revert to old Brown Act regs, or AB 2449
 - Old Brown Act required people zooming in to be a public meeting location.
 - Additional discussion next week.

 - AB 2449 - physical location needs to have a quorum
 - Allows for just cause exception, can be used twice.
 - Allows for emergency exception with many requirements.
- Summary: Full virtual meetings will not be possible in the future, and even hybrid meetings will be challenging due to both Brown Act and AB 2449 being heavily restrictive but in different ways.
