2. PREAPPLICATIONS:

- **A. PARCEL MAP/Jensen** (~ 1:30 p.m.). Proposal to divide 17.9-acre parcel (APN 026-360-002) into two parcels of 3.61 and 1.77 acres, respectively, and a remainder of 12.68 acres off Chalfant Road. The property has prior Parcel Map 37-75, with residences on both proposed parcels. *Staff: Gerry Le François, principal planner*
- **B. VACATION RENTAL CABINS/Dunstone** (~ 1:50 p.m.). The proposal is to allow for 1-10 rental cabins at 70752 Hwy. 167 (APN 013-240-005). The property is 48.33 acres, has a land use designation of Resource Management, and is 20.5 miles from Lee Vining and 30.5 miles from Bridgeport. A well and septic system serves the existing single-family residence. Property management would live on site. *Staff: Courtney Weiche, associate planner*

3. APPLICATION ACCEPTANCE:

A. EXPANDED HOME OCCUPATION/Draper (~ 2:10 p.m.). Owner proposes to cut, split, and deliver firewood as needed to buyers. Owner is the sole employee and on-site wood storage would be limited to one cord of firewood. Business would be conducted as needed, but may operate seven days a week. The property (APN 011-040-029) is approximately 1.3 acres located at 110 Mt.
