- \$8,042 contract services for Municipal Service Review (MSR) updates (amount corrected from staff report)
 - Contract not to exceed \$20,000

- \$5,811.59 for LAFCO staff costs
 - Likely high due to reporting system

Amendment

- Reflects full amount billed to funding districts
- Amendment allocates \$15,000 from reserves for contract services to fund Municipal Service Review (MSR) updates
