Required Contents of the Resolution:

- 1. A statement that the proposal is made pursuant to Government Code Section 56654.
- 2. A statement regarding the nature of the proposal and a list of all proposed changes of organization.
- 3. A statement of the reason or reasons for the proposal.
- 4. A description of the external boundary of the affected territory accompanied by a map showing that boundary.
- 5. The stated proposed terms and conditions.
- 6. A statement whether any city and/or district sphere(s) of influence must be amended or adopted in conjunction with approval of the proposed change of organization.
- 7. A request that proceedings be taken for the proposal pursuant to Government Code Section 56654.
