- ❖ **The YARTS 395/120 route is scheduled to run through September 30, 2024. Please note that there will only be one run a day September 1, 2024 through September 30, 2024.**
- ❖ Applicant must be 18 years of age and older, and a resident of Mono County.
- ❖ One free ticket voucher will be issued per resident per application. The ticket voucher will cover the cost of the Applicant's round-trip ticket, as well as the cost of round-trip tickets for the Applicant's children aged 0-17.
- ❖ All applicants must submit proof of address (government issued identification, vehicle registration, signed lease, utility bill, etc.) to verify residency. If using a utility bill, both the service address and the mailing address must be visible and located in Mono County.
