RE: OPPORTUNITY FOR PUBLIC INPUT ON MONO COUNTY LOCAL TRANSPORTATION COMMMISSION'S 2026 REGIONAL TRANSPORTATION IMPROVEMENT PROGRAM

The Mono County Local Transportation Commission (MCLTC) released its proposed projects under its 2026 Regional Transportation Improvement Program (RTIP), which is a multi-year capital improvement program that advances priority projects in the region. The MCLTC views public participation as an important part of the planning process and encourages public input on proposed transportation projects.

Every two years, the California Transportation Commission (CTC) adopts a fund estimate that explains the distribution of funding to each jurisdiction in California over five fiscal years. To obligate funding, each planning agency submits an RTIP that reflects a list of priority projects. These regional projects are added to the State Transportation Improvement Program (STIP) along with interregional projects programmed by Caltrans. The MCLTC received an allocation of \$4.882 million through Fiscal Year 2030-2031.
