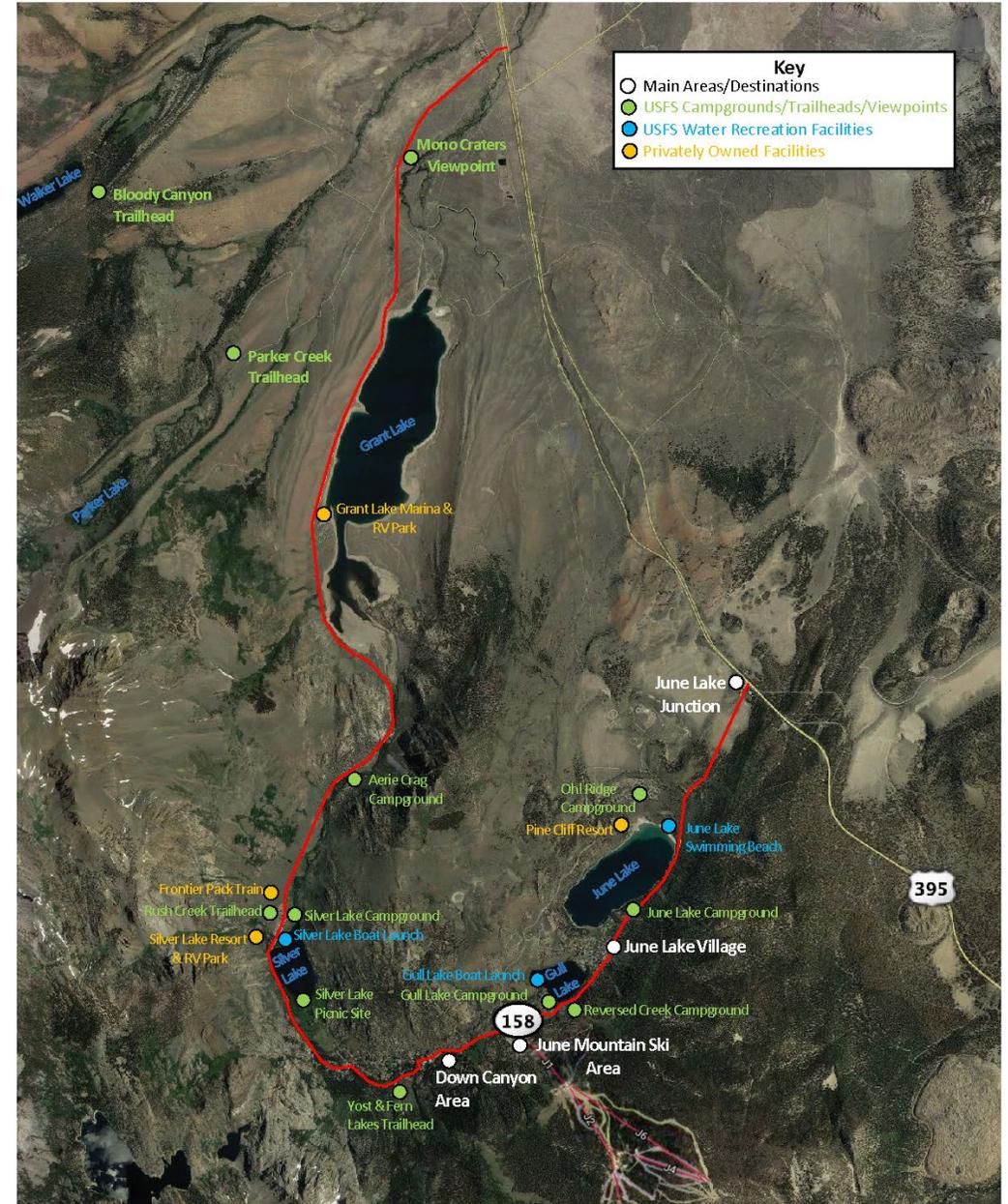
Goals of the ATP

- Identify gaps in the active transportation network
 - Sidewalks, curb ramps, crosswalks, bikeways, transit stops, etc.
- Assess collision data (location and type of crash) and other datasets important to the unique characteristics of the SR 158
- Engage with community members and stakeholders
 - Trouble Areas and Opportunity Areas
- Assess parking locations (vehicular and bicycle)

Project Area Map

- State Route 158
- Connect to major destinations such as:
 - June Lake Beach
 - June Lake Village businesses and community spaces; Gull Lake
 - June Mountain Ski Area
 - Resorts and lodging between Silver Lake and Gull Lake (Down Canyon)
 - Silver Lake resort and campgrounds and Grant Lake Marina and campgrounds


June Lake Loop (SR 158) Project Area Map



Engaging CAC in the ATP

- Engage as the main Advisory Group for the project
- Provide ideas and strategies to engage with community members and other stakeholders
- Identify important sensitivities and topics to consider regarding the conditions, history, and needs of the community.
- Venue to discuss plan concepts derived from stakeholder input and strategies for plan implementation
- Scoped to engage at least two times during project
 - Can also provide regular updates through County Staff
- Become ambassadors of the project and help promote


ATP Timeline



Existing Conditions Data

- Existing and previously proposed active transportation improvements
 - Bikeways, crosswalks, sidewalks, lighting, signage, etc.
- Land use / community destinations
- Right-of-way / parcel information
- Topography
- Trails and trailheads
- Planned projects (housing, resorts, etc.)
- Collision analysis
- Review of previous planning efforts (June Lake Area Plan, Mono County General Plan, etc.)

Existing Conditions Mapping



Unique Characteristics to Consider

- Topographic changes along the loop
- Seasonal changes
 - Population influxes
 - Highly cyclical tourism-based economy
 - Maintenance of facilities
 - Hazards
- Rural neighborhood characteristics
- Natural setting and scenic resources i.e.
 - Tree cover and vegetation
 - Viewpoints and points of interest
- Jurisdictional agencies (Caltrans vs County vs U.S. Forest Service)
