1. Opportunity for the Public to Address the Board

2. FY 2026-2027 Budget Request Proposal

- MLPD Chief Casabian returned to the CCP to answer the questions and concerns that were discussed at the April 15th meeting.
- MLPD does have a AI policy as MLPD has been using AI and Draft One from Axon for 3 months now. Chief Casabian explains how these features will support the CCP Strategic Plan.
- Executive decides to support and fund the 5-year contract for Axon's translation and auto transcribe. However, only one year of funding for the Draft One AI component.
- Executive recommends MLPD to request support and funding from Mammoth Town. If the Town chooses not to fund this proposal, the Executive request MLPD to bring the proposal back to CCP.
- Action: Director Roberts makes the motion to approve Axon's translation and auto subscribe 5-year contract and AI Draft One for one year. DA Anderson seconds. All in favor, motion passes.

3. Final FY 2026-2027 CCP Budget

Recommended Action: Review and approve or deny proposed budget for FY26/27.

- Action: Robin makes a motion to approve the FY26/27 proposed budget to include proposals from Probation and MLPD and DA Ibrahim seconds. All in favor, motion passes.
