SAVE ON HIRING/ TRAINING COSTS

Hire. Train. Save.

Mono County Workforce Services can help you save time and money hiring and training staff. We administer state and federally funded programs which combine wage-paid work and job skills training to help individuals succeed in the workforce, and to help employers find effective solutions to their staffing needs. Everyone benefits!

1. Subsidized Employment

Mono County Department of Social Service's Subsidized Employment program goals are to place Welfare to Work (WTW) participants in subsidized employment positions with private and public sector businesses, so that the participants can obtain valuable work experience, recent work references and eventual unsubsidized employment and self-sufficiency. In the first six months of subsidized employment, the wage subsidy will be **100% reimbursement.** If any extensions past six months are granted, the wage subsidy will be **50%.** This payment structure is designed to incentivize a quick and effective hiring process for WTW participants.

It's a **win-win:** Participants gain valuable work skills and experience to further their career goals, and the employer benefits from the extra assistance and increased productivity.

2. On-the-Job Training

Reimbursement Equivalent to Training Costs

The On-the-Job Training (OJT) program enables businesses to hire qualified employees and receive a reimbursement for a portion of that employee's wages during the training agreement that is equivalent to their training costs.

You decide who to hire, then train your employee to perform their job according to your specifications.

Big Savings

We will reimburse you 50% of each new employee's hourly wages during the training agreement. The *On-the-Job Training* period may vary according to the complexity of the job and the skills of the trainee. The length of the contract may range from 140 to 480 hours.

A Winning Partnership

By utilizing our On-the-Job Training program, we will not interfere with your work schedule and will make it easy for you to hire the people you need. Our representatives will prepare a contract from your job description. We gather the paperwork, get your approval, and then your new trainee starts to work.
